2. ADD Clause 8.6.6.3

8.6.6.3 For Work performed under 8.6.6.1, the Contractor shall be paid a Call-up minimum of the greater of either:

- A. one (1) hour at after-hours hourly rate; OR
- B. the total amount for the actual hours worked, as defined in 8.6.6.1, and total travel time and material used.

This amount is to be paid only in connection with Work issued under 8.6.6.1 and is to be applied once only, per Call-up.

3. QUESTION AND ANSWER :

Question 1: We have seen that you need a construction company for your projects. We are interested and would like to have more details on the work to be done. Can you tell us how we can send you a submission?

Answer 1: Please refer to section 2.2 Submission of Offers, Part 3 Offer Preparation Instructions, Part 4 Evaluation Procedures and Basis of Selection, Attachment 1 to Part 4 Technical Criteria, and Annex A Statement of Work. For the information on the work that may be required, you may review the Appendices Folder, Appendix 5, SUR usage report that provides historical data on the type and quantities of activities in the past.

Question 2: We want to clarify section 8.6.6.1:

The hourly rate applies to outside normal working hours is calculated by multiplying by 1.5 the regular hourly rate indicated on the offer form.

The hours worked include the time spent on the phone with the CFHA occupant and/or the representative in Ottawa and/or the CFHA representative for a service call without travel.

Example: a minimum of 1 hour will be paid at an hourly rate of 1.5 according to the price listed on the offer for the time spent on the phone only

Answer 2: Currently, as per 8.6.6.1, "hours worked is defined as actual time worked". Payment will only be for the **actual** time spent on the phone with a commissionaire and/or the occupant, and the actual time spent at the work site. There is no minimum time for communication or the work, and the hours worked are not rounded up or down. Hours worked excludes time spent by the Offeror mobilizing its own workforce.

Example: an Offeror spent 13 minutes on the phone with the commissionaire and 22 minutes on the phone with an occupant. The situation was resolved during the phone call, and no visit was required. The regular hourly rate on the Offeror form is \$100.00.

The payment will be for 0.58 hours (35 minutes) x 1.5 times the regular hourly rate indicated on the Offer Form. The payment is $0.58 \times (1.5 \times \$100) = \$87.50$

Canada has made a decision to amend the RFSO and include a minimum payment for After Hours Work. The minimum payment will be the greater of 1 hour at after-hours hourly rates OR the actual invoice amount based on actual hours worked, total travel time and material used.

In the example above, the payment under the new clause will be \$150.00
