THIS AMENDMENT IS RAISED TO REVISE THE RESPONSE TO QUESTION #3 IN THE QUESTION AND ANSWER – SERIES I. THE FOLLOWING REVISION IS:

- 1. At QUESTION AND ANSWER – SERIES I, Q3 and A3, DELETE in its entirety and REPLACE with the following,**

“Q3. The RFI(LOI) indicated that the international trade agreements apply yet it also indicates that the ITB Policy may apply. Please advise and confirm which applies.

A3. Currently, all trade agreements apply to the requirement identified in the RFI (LOI) as a decision on the invocation of the National Security Exception (NSE) has not yet been made. Should the NSE be invoked for this project, Canada will make a determination using feedback from the industry engagement process (e.g. Industry Days, one-on-one sessions, RFIs) and internal consultation with stakeholders to achieve the appropriate balance between capability, cost and economic benefit to Canada. Once the project reaches the Definition Phase, Canada will determine if the ITB Policy, including Value Proposition, will apply to the requirement identified in this RFI (LOI).”
