Amendment 001 has been raised to publish all answers to questions received to-date.

A. QUESTIONS AND ANSWERS

- Q1.** Can a Dentist submit a response to this solicitation if he/she can provide any or all of these supplies?
- A1.** **Yes, a dentist may submit a response to this solicitation if they are a supplier that is authorized to sell the goods or provide services in Canada. These must fall within the allowable goods and services identified in Annex A, Article 1.**
- Q2.** The supplier has to provide a quote for all the items listed in the solicitation or it can be a partial quote for a few items?
- A2.** **There are no items listed in this solicitation. We are not requesting a quote through this solicitation. Under the Request for Supply Arrangement, the supplier is asked to identify which of the UNSPSC Dental classes (categories) of goods they are offering and that they are authorized to sell in Canada. If suppliers choose to submit a price list, they must complete the Dental Price List in Annex F, in accordance with the instructions in the solicitation document. The supplier can choose however many items they wish to include on the price list. The unit prices submitted in Annex F, Dental Price list represent a discounted unit price that will apply for at minimum 1 calendar year.**
- Q3.** Is there any particular brand for any item on the list for Dental Instruments, materials or equipment?
- A3.** **We have not set any particular brands and are leaving it open for the supplier to indicate based on what they are authorized to sell in Canada.**
- Q4.** Is there any details on Dental clinic furniture?
- A4.** **No. Details on any requirements will come through subsequent Request for Proposals (RFP) sent to the list of qualified suppliers resulting from this RFSA process.**
- Q5.** What are the items needed for office furniture?
- A5.** **Office furniture is considered a Non-Allowable goods under this solicitation. See Annex A, Article 1.3.**
- Q6.** Can you offer some clarification on the differences between the Supply Agreement and Standing Offer options?
- A6.** **Supply Arrangements are non-binding agreements between Public Works and Government Services Canada (PWGSC) and pre-qualified suppliers to provide a range of product or services on an as-and-when-requested basis. The Suppliers that are issued a Supply Arrangement will form a list of qualified Suppliers from which the Government of Canada can solicit bids and award contracts based on the specific requirements.**
