The following changes in the tender documents are effective immediately. This Addendum will form part of the contract documents.

1. QUESTIONS/RESPONSES

Question #1:

Your schedule of 4 weeks from date of contract award is not doable and a more realistic schedule is 2.5 to 3 months. If the schedule is 4 weeks and can't move we can certainly look at running crews 24 hours per day 7 days a week and bringing in workers from all over western Canada, but the cost will be significant. Please also confirm if there are penalty clauses as I have seen many contractors promise short schedules, but then not deliver on that schedule and since there are no penalties there is nothing the owner can do.

Response to #1:

PWGSC is accepting of an increase to the completion schedule for the Contract to a maximum of eight (8) weeks from contract award, with the completion of all site work and Substantial Completion no later than March 31, 2022.

Penalty clauses are not included in the Contract.

Question #2:

Please confirm if damage to surfaces surrounding the building, such as asphalt, is acceptable. We will be falling material and driving steel tracked excavators around the perimeter of the building and those surfaces will be scuffed and marked.

Response to #2:

Refer to Section 02 41 16 Clause 3.1.2 in its entirety.

Question #3:

Please confirm that the personnel gate at the SE corner of the building will be removed prior to our mobilization

Response to #3:

The existing personnel gate and other existing fencing, where it interferes with the project worksite, will be removed prior to the contractor's mobilization. The contractor is responsible to protect the existing electrical vault and turnstile electrical service per Section 02 41 16 Clause 3.1.2.6.

Question #4:

Who is responsible to disconnect and make safe all utilities to the building, eg gas, power, water?

Response to #4:

All services to the building have been disconnected by PWGSC.

Question #5:

It was noted that there is a fire hydrant at the southeast corner of Building 1007. Will this remain operational during the work?

Response to #5:

Water to the fire hydrant will be isolated, the hydrant removed and above grade flange capped by PWGSC prior to the mobilization by the Contractor. The Contractor shall protect the remaining above grade capped flange from damage during the execution of the Work. The fire hydrant in question is shown on Page 3 of this Addendum

Question #6:

There are two access doors at the building directly adjacent to the project worksite. Will these doors remain active during the work?

Response to #6:

Both access doors will not remain active during the execution of the Work. The roll-up door to the right of the man door shall remain active in support of on-going tenant operations. The roll up door is identified with the number 5. The doors in question are shown on Page 4 of this addendum.

Question #7:

Is there a price form associated with this bid that may be missing?

Response to #7:

Refer to BID ACCEPTANCE FORM (BA) – REVISED JANUARY 26, 2022 found in Solicitation Amendment 003.
