**Question 13:** In the solicitation document it mentions a large number of organizations across the country who will have access to the NMSO.

- a. Do you have agreements in place with these organizations?
- b. Would you please advise how you plan to communicate that this NMSO is open to them?
- c. Will you be circulating copies of the NMSO to all non-RCMP organizations?
- d. Do you have a master contact list that the successful bidder will have access to, for follow-up purposes ?
- e. Regarding the RCMP's requirements will your office handle all orders for all Divisions or is it incumbent on the successful bidder to reach out to each division?

**Answer 13:**

- a) The organizations listed in the Request for Standing Offer have all indicated interest in using the NMSO, as such they will issue call ups when a requirement arises.
- b) The NMSO will not be circulated as it is posted on the Standing Offer/Supply Arrangement (SOSA) app, which is accessible by all of the identified users.
- c) No contact list will be provided. Identified users will issue a call up when a requirement arises, which will contain all of their contact information.
- d) Each identified user including each RCMP division will be responsible for their own call up.

**Question 14:** Flashlights are a commodity item, pricing is based on volumes. While the Solicitation mentions a long list of potential users, no information on minimum volumes is provided. Would you please advise what are volumes for the items you plan to purchase?

**Answer 14:** As mentioned in Question 8, we cannot provide an accurate estimation as this tool is available to multiple Departments, as such we are unable to forecast the projected usage.

**Question 15:** Will the use of the NMSO be mandatory for all RCMP Divisions and other participating groups named in the NMSO?

**Answer 15:** The NMSO is not a mandatory tool. The identified user is free to procure outside of the NMSO should they feel that the tool doesn't meet their needs.

**Question 16:** The Solicitation calls for the provision of a battery charger with the kit. Battery chargers come in a variety of configurations and capacities, with pricing that reflects their features. Would you kindly provide the following information:

- a. How many batteries do you want to charge at the same time (2, 4, or more)
- b. Do you want a switching power supply 110v-220v or simply 110V.
- c. Do you want a USB charging port?
- d. Do you require "fast charge" Capability?

**Answer 16:**

- a. At minimum, the battery charger must be capable of charging the number of batteries required to operate the flashlight.
- b. There is no specific requirement for switching power supply, this feature is at the bidder's discretion.
- c. There is no specific requirement for a USB charging port, this feature is at the bidder's discretion.
- d. There is no specific requirement for a fast charging capability, this feature is at the bidder's discretion
