Part 1. Interpretation

- 1.1** Elections Canada hereby amends in accordance with this amendment the Request for Proposal for Managed Hosting Services bearing number ECBH-RFP-2021-0381 and dated December 29, 2021 (the “RFP”). This amendment hereby forms part of the RFP.
- 1.2** Unless defined herein or unless the context otherwise requires, all of the words and phrases defined in the RFP and used in this amendment shall have the same meanings assigned to them in the RFP.

Part 2. Questions and Answers

The following questions have been asked in response to the Request for Proposal and Elections Canada hereby answers as follows:

2.1 Question No. 7

Question: Mandatory requirement #1 – Will Elections Canada accept a proposal from a company that does not host Moodle, but allows for migration of Moodle content?

Answer: No, at this time Elections Canada is only considering Moodle and Moodle derivative platforms.

2.2 Question No. 8

Question: Mandatory requirement #2 – Will Elections Canada replace the requirement with “The proposed solution must run the most up-to-date version of the LMS platform”?

Answer: The proposed solution must be able to be updated to the most up-to-date version of the LMS platform, but may run an older version at time of contract initiation (minimum version 3.5.18) and be updated to the latest version subsequently. To simplify administration by both parties, running the most-up-to-date version from the contract initiation is encouraged. Also note that as stated in the RFP, suppliers offering a Moodle-derivative platform are responsible for clarifying the relation of their platform to the release schedule and version numbering of the main Moodle development project.

2.3 Question No. 9

Question: Rated requirement #2 – in relation to our question number 2, can this be replaced with “most up-to-date version of the LMS platform”?

Answer: The proposed solution must be able to be updated to the most up-to-date version of the LMS platform, but may run an older version at time of contract initiation (minimum version 3.5.18) and be updated to the latest version subsequently. To simplify administration by both parties, running the most-up-to-date version from the contract initiation is encouraged. Also note that as stated in the RFP, suppliers offering a Moodle-derivative platform are responsible for clarifying the relation of their platform to the release schedule and version numbering of the main Moodle development project.
