OPTIONAL SITE VISIT

General Information:

There will be optional site visits on **February 2nd, 2022** and **February 10th, 2022**. Interested bidders are asked to register by emailing Alexandria.Dwyer@pwgsc-tpsgc.gc.ca to obtain an assigned time slot for the site visit. On the day of the site visit Bidders can meet at 280 Southside Road, St. John's, NL.

Bidders must communicate with the Contracting Authority no later than **February 1st, 2022 at 12:00 PM** to confirm attendance for the site visit on February 2nd, 2022 and provide the name(s) of the person(s) who will attend.

Bidders must communicate with the Contracting Authority no later than **February 9th, 2022 at 12:00 PM** to confirm attendance for the site visit on February 10th, 2022 and provide the name(s) of the person(s) who will attend.

All personnel visiting the site shall provide their own personal protective equipment (PPE). The PPE shall include as a minimum safety glasses, boots, hard hat and vest.

Bidders may be requested to sign an attendance form. Bidders who do not attend or send a representative will not be given an alternative appointment but they will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.

COVID-19 Protocols:

The site visits are subject to the COVID-19 Vaccination Policy for Supplier Personnel. Bidders must complete and submit the vaccine attestation located in **SI03** of the solicitation document with their registration.

All Public Health Guidelines are to be followed, including but not limited to wearing a mask and physical distancing.

The Canadian Coast Guard has implemented COVID-19 prevention measures which include mandatory rapid testing for anyone entering the Canadian Coast Guard facilities. As such there will be **mandatory** Covid-19 rapid testing provided on site before the site visit starts.
