Amendment No. 1 to Request for Proposal

GYM FLOOR MATS

This amendment is raised to answer a question asked by potential bidders:

Question #1: What is the reason the 'proposed mats must have a hot-sprayed poly-vinyl coating surface?

Answer #1: The surface must be able to withstand moisture and damp cleaning and disinfecting. The surface must be smooth to the touch as people's faces will be on them.

Question #2: Will US Rubber Survivor Sport Gym Flooring Tiles (See attached) be an acceptable alternative related to available colour options? For example – Page 3. Isometrics, Standard Black with 10% Blue "109" color fleck?

Answer #2: Flooring tiles are not an option. These mats must be easily placed and removed. Rolled and stored not stacked. They must be soft and absorb impact of a person being taken to the ground. The color you are suggesting is not acceptable, it about 90% black with only a blue spec.

All other terms and conditions remain unchanged.
