A. Questions & Answers

Q4. We are having difficulty putting together a price for Cat 1 as there is a lot of information missing. On some of the work stations the panel length is 6'4" which cannot be achieved with a combination of 30" and 36" wide panels. Also, it appears that some of the stations have a 24" panel at the end. We do not know if the power is coming from the ceiling or a base feed and the panels against a wall are not required, especially with a glass upper element. Can you please clarify these areas?

A4. It appears that an old version of the floor plan outlining the panels was sent with this solicitation. A revised version of Annex C will be provided which will show a layout that ties in with the panels being requested.

Regarding the question about power, you will see this outlined in the revised Annex C.

The CRA agrees that panels against a wall with a glass element are not required and will adjust the Cat 1 product table accordingly. Please reference Amendment #3 below.

Q5. With regards to cat 6, Item #8 for Individual work pods (6OIWWSFLXC1H47XYXX), would you be able to consider a 72" long table (6CMUSHDSRL42L72WYXX) instead of 60"? The rest of the specifications would be the same and based on the floor plans, it appears that the office space could handle this size.

A5. The CRA can accept a longer table for this space and updated the RFB accordingly. Please reference Amendment #4 below.
