Pages 1 and 4 instruct to submit proposal through e-mail, but Page 8 instructs to submit through the epost Connect system. Which is the correct method of submittal?

Question 2:

Page 8 indicates 1 soft copy of Sections 1 through 4. Are we to submit 4 separate pdf documents titled by section, or do we submit all Sections under one combined pdf document?

Question 3:

As this project is virtual in nature, is a COVID-19 Certification necessary for this submittal, as travel will not be required?

Response:

The COVID-19 Mandatory Contractor Vaccination Certification Form is required for any supplier holding a valid Contract or Purchase Order with Transport Canada. Different options are available within the form if no site access is required for the performance of the Contract.

If you are a foreign company and have personnel (resources/employees) who require access to Government of Canada workplaces within Canada, they are required to be fully vaccinated, and the required Certification Form must be completed.

Question 4:

If the COVID-19 cert is required, please define fully vaccinated (what defines a full series of vaccinations - 2 shots; 2 shots and a booster?). Are there any exemptions, and if so, what are they?
