**Q1.** I would like to have further clarification on the size rule for submitted proposals. Does the rule that the proposal cannot be more than ten pages include the combination of the Technical bid, Financial bid and Certifications?

If hyperlinks to websites with published material cannot be used to demonstrate such works, then in addition to placing resumes in some form of annex, can all other examples of published works and regulations worked on (other than just titles), be added to Annexes to the proposal, without the 10-page cutoff rule applying?
