TITLE – REQUEST FOR STANDING OFFERS–NATIONAL MASTER STANDING OFFER FOR AIR CHARTER SERVICES

This Amendment No. 007 is issued to amend the Request for Standing Offers – National Master Standing Offer for Air Charter Services (RFSO) as follows:

1. Publish the complete RFSO Amendment 007 as an attachment to this document, so that the hyperlinks in the document are active:

5. Insert e-Procurement Solution (EPS) considerations.
6. PART 4 – discard **facsimile** and **mail** requirements.
7. Comprehensive overhaul of PART 5, with updated certification requirements included in Attachment 3 to PART 3.
8. Under 7A.8 (Call-up Procedures), clarify
 - the Non-competitive contracting process provisions; and
 - the Procurement Strategy for Aboriginal Business (PSAB) provisions.
9. Update 7B.4 (Proactive Disclosure of Contracts with Former Public Servants)
10. Expand clause to 7B.5.2 (Single Payment)
11. Organize 7B.8 (SACC Manual Clauses) to segregate call-up specific
