## 2.7 Mandatory Site Visit

It is mandatory that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for the site visit to be held at Canadian Food Inspection Agency, Lethbridge Laboratory, Township Toad 9-1, Lethbridge, AB T1J 0P3 on February 8, 2022. The site visit will begin at 09:00 a.m. (Mountain Standard Time), waiting in the lobby for the Technical Authority.

This site visit is subject to the COVID-19 Vaccination Policy for Supplier Personnel.
