### **Title: Workspace Office Furniture**

(1) This solicitation is hereby amended to provide the following questions and answers:

**Q1: Category 1B, line 1 (1bCPSXXXSXXL30XFANNN) and 2**

**(1bCPSXXXSXXL48XFANNN):** Clamped-on fabric privacy screens. Does the reference to clamped-on mean that they are quickly removeable or is a more permanent attachment solution acceptable?

A1: Both a removeable and permanent attachment are acceptable as long as it is attached to the surface and has the ability to move up and down with the surface.

**Q2: Category 1, line 1 (1bFFHREC24L42WNOLNY), 2 (1bFFHREC24L60WNOLNY) and 3 (1bFFHREC30L60WNOLNY):** Are supports/legs other than C-legs acceptable please?

A2: Post legs is also acceptable. The GoCUIDs are the following: line 1: 1bFFHREL24L42WNOLN/ line 2: 1bFFHREL24L60WNOLNY/ line 3: 1bFFHREL30L60WNOLNY

**Q3: Category 3, line 1 (3LSL2HXXPM18D20XHXS) and 2**

**(3LSL3HXXPM18D20XHXS):** Storage Locker with digital lock. Are these lockers for assigned or non-assigned use please?

A3: It will be for mixed used. All the lockers will be programmed for non-assigned used during COVID but the client should have the ability to reprogram them to assigned used if needed. If the lock type requires an additional programming key to program the lockers between assigned and non-assigned, please provide the necessary programming tools.
