**This Request for Proposal Amendment 02 is raised to make the following changes to solicitation number W8484-220232.**

***The purpose of this amendment is to answer questions from potential bidders and amend Annex "A" - Statement of Work.***

---

**Q1** - With regards to the accommodations, is there any preference for single or doubles?

**A1** - There is no preference, however all rooms must be single-occupancy.

---

**Q2** - Since the closing date is very close to the training date, can a 24 hr turnaround for award be completed?

**A2** - Following the solicitation period, Canada will award a contract as soon as possible.

---

**Q3** - Is it possible to move up the closing date to Feb 11 as the availability of rooms are very hard to secure? Hotels need to release rooms to regular sales if the blocks of room are not required by CAF.

**A3** - The solicitation timelines cannot be reduced as international trade agreement obligations must be respected.

**Q4** - Can clause 1.6.2 be reviewed, as there are multiple events occurring at the same location and time?

**A4 - ANNEX "A" – Statement of Work**

1.6.2 The CAF POC will inform the contractor no later than seventy two (72) hours before any associated occupancy date cancellations. The CAF POC will be responsible to provide a list of the names of the personnel utilizing the accommodation at least seventy two (72) hours prior to the occupancy dates with the exception of unforeseen circumstances.

**Q5** - Is it possible to review the requirement for Section 1.5.3.3 under Annex A? This section requires all rooms to be accessible only through internal hotel hallways and not through exterior doors.
