Amendment 003 has been raised to publish all answers to questions received to-date and to modify the Request for Supply Arrangement (RFSA).

A. QUESTIONS AND ANSWERS

Q16. In Annex F, Dental Price List, do you want the discounted price in column E (Unit Price)?

R16. **Yes, the Unit Price in column E must be the discounted price. The unit price must be in Canadian dollar currency and include any applicable discounts, customs duties, and excise taxes. The unit price excludes any applicable taxes and delivery. Note the RFSA modification in part B of the French version of the amendment (B2). No modification was required in the English version of the RFSA.**

Q17. In Annex F, Dental Price List, do you want the suggested list price in column L (Market Price)?

R17. **Yes.**

Q18. In Annex F, Dental Price List, our understanding is that you only want one file with the total of all our supplier's prices and we are not to create separate tabs?

R18. **Yes, we only want one file with all of your offered prices for the products authorized under the Standing Offer sub-agreement with a unit price limit of \$25,000.00 CAD or less. Do not create separate tabs.**

Q19. In Annex F, Dental Price List, our understanding is that it is not mandatory to fill in the columns in green (H,I,J,K et L) but if we do, will we get additional points in our evaluation?

R19. **The columns in green (H,I,J,K et L) are optional. If you complete these columns entirely, you can get an additional 15 points that will be applied to the points achieved in the Point Rated Technical Criteria section of the Technical Evaluation.**

Q20. In Annex B, Product and Discount Template, do we have to fill out column B Class Title?

R20. **No, nothing should be entered into column B.**

Q21. In Annex A, Article 3.10 Packaging, it says that all goods must be labeled in both official languages, English and French. Does this apply to us, as we are a distributor?

R21. **Yes this applies to all suppliers who submit an arrangement pursuant to this RFSA. It is the responsibility of the supplier to know and conform to all applicable Federal and Provincial legislation and regulations concerning packaging, labeling and movement of hazardous goods including goods which are repackaged by the Supplier.**
