Title: Cemetery Maintenance, Newfoundland and Labrador

This solicitation is hereby amended to respond to the following questions:

Question 1

I am sure there are numerous headstones in these cemeteries, even of other Veterans who's markers are not to be repaired in any way as part of this tender.

How are the grave sites to be identified to potential contractors?

Are the grave sites in question currently marked or will they be marked by Veterans Affairs prior to bid closing?

Please advise.

Answer 1

All of the cemeteries that form part of this tender were inspected by Veterans Affairs staff in 2021 and the repairs identified resulted from these inspections. The markers inspected are those that fall under the care and responsibility of Veterans Affairs Canada. It should be noted that the Commonwealth War Graves Commission is responsible for maintaining markers for the war dead and additionally, cemeteries may also have privately owned, family markers that may appear similar to the traditional military-style markers, however, these markers do not fall under the care and responsibility of Veterans Affairs.

The list of markers will be provided to the successful bidder once the contract has been awarded. The Veterans' names and a description of the location of each marker will be provided, as well as the GPS coordinates, to assist the contractor in locating each marker.

The markers are not currently marked and will not be marked prior to the closing of the bid. The list of repairs is broken down by marker type to assist potential bidders in pricing out the cost of the repair work.

Question 2

Has there been a tender for cemetery maintenance issued before? If so, could you please forward a copy of the pricing.

Answer 2

Similar contracts have been issued for Cemetery Maintenance work in Newfoundland and Labrador in previous years. The pricing of our Contracts is proprietary to the Contractor and we are unable to share that information.
