Solicitation Amendment No. 002 is being issued to address each of the following:

A) Questions and Answers

Q1: What is the thickness of steel sheets is to be considered?

A1: We will not be shredding steel sheets. Steel scraps like steel toe boots and rucksack frame no thicker than 1/4" may be shredded.

Q2: Do the jackets have bulletproof protection inside?

A2: No.

Q3: What is the approximate size of the biggest product that will be introduced into the hopper?

A3: Large textiles like overcoats and parkas.

Q4: What percentage of material will be plastics, textiles, wood, hard drives, and metals?

A4: Plastics: approximately 5% (includes buttons, zippers). Textiles: Less than 85%. Wood: Greater than 5%. Hard drives: 0%. Metals: Greater than 5%.

Q5: Metal compared to everything else requires a different machine. Depending on the percentage of metal, a machine for it may not be required, please advise.

A5: If the shredder is capable of destroying items with small parts of metal it will suffice. It will not be used to shred large amounts of metals, or large pieces of metal.

Q6: What is meant by self cleaning blades?

A6: Self-cleaning is used to refer to blade maintenance. We do not want to have to constantly sharpen/replace blades due to dulling.

B) At Annex A – Statement of Requirement, Section 4.1 to 4.1.9.4

Delete in its entirety;

Insert:

4.1 Shredder:

4.1.1 Must be top Loading Hopper with collection point underneath.

- 4.1.2 Must be of metal construction and larger than the cutting chamber to accommodate stock being shredded.
- 4.1.3 Must have an overhead mirror to allow the operator to monitor the shredding process from the conveyor belt loading area.
- 4.1.4 Shredder discharge must accommodate a output bin or pallet container with the minimum dimensions 48" wide x 40" thick x 34' length.
- 4.1.5 Shredder cutting chamber must handle products 48" wide x 18" thick x 5' length.
- 4.1.6 Cutting chamber must have steel bulkhead walls with self-cleaning blades. Self-cleaning blades is used to refer to blade maintenance. They do not have to be constantly sharpened and replaced due to dulling.
 - 4.1.7 Maximum dimensions of shredded products is 30 mm or less by random length.
 - 4.1.8 Shredder must have a self-cleaning cutter and all applicable safety systems as per Canadian standards
- 4.1.9 Shredder must process a wide range of products, including but not limited to:
 - 4.1.9.1 Plastics defined as plastic head pieces from ground troop helmets, buttons, and zippers;
 - 4.1.9.2 Textiles defined as in Cadpat shirts and pants, ice jackets when bundled up could be up to 18" across, rain pants and jackets, no bulletproof protection jackets, overcoats, parkas, helmet covers, and gloves;
 - 4.1.9.3 Wood scraps no thicker than 2";
 - 4.1.9.4 Metals defined as steel toe boots and old frames of rucksacks no thicker than 1/4".
