### **(A) QUESTIONS/ANSWERS**

#### **Question 1**

On page 27 BA03 The Offer Price – Item #1 – To what level are we to design the modules? Is Stamped Architectural, Structural, Electrical and Mechanical to be done by the successful bidder?

#### **Answer 1**

The units are already basically design however the resulting Contractor must further expand upon the design to complete the units. A completed set of engineered sealed structural fabrication drawings are required for review of all components of each module on the project.

#### **Question 2:**

Please confirm that the design consultants will NOT be required to provide stamped and sealed drawings for the jurisdiction in which the unit will be installed. Please confirm that any design consultants involved in the project are only required to hold registration in the jurisdiction in which the units are initially designed and constructed.

#### **Answer 2:**

The resulting Contractor is not required to stamp and seal drawings for the jurisdiction in which the units are installed but must stamp and seal fabrication drawings in the Province or Territory they are manufactured, in accordance with the National Building Code or as defined in the contract documents.
