### **Description of the Requirement:**

Health Canada (HC) is seeking to issue a contract for a resource (or a team of resources) for Editorial Services under the Task and Solutions Professional Services (TSPS) Supply Arrangement (SA) for Solutions-based professional services under stream 3: Project Management Services. The work to be performed is detailed under Annex "A" Statement of Work. The Contractor's resource(s) are required to work off-site at their own facilities with an anticipated contract period from April 1, 2022 to March 31, 2025.

### **Level of Security Requirement:**

1. The Contractor must, at all times during the performance of the Contract, hold a valid Facility Security Clearance at the level of **SECRET**, with approved Document Safeguarding at the level of **SECRET**, issued by the Contract Security Program (CSP), Public Works and Government Services Canada (PWGSC).
2. The Contractor personnel requiring access to CLASSIFIED information, assets or sensitive site(s) must EACH hold a valid personnel security screening at the level of **SECRET**, granted or approved by the CSP, PWGSC.
3. The Contractor MUST NOT utilize its Information Technology systems to electronically process, produce or store any sensitive CLASSIFIED information until the CSP, PWGSC

has issued written approval. After approval has been granted, these tasks may be performed at the level of **SECRET**.

4. Subcontracts which contain security requirements are NOT to be awarded without the prior written permission of the CSP, PWGSC.
5. The Contractor must comply with the provisions of the:
  - (a) Security Requirements Check List and security guide (if applicable), attached at Annex C;
  - (b) *Contract Security Manual* (Latest Edition).

**Proposed period of contract:**

The proposed period of contract shall be from April 1, 2022 to March 31, 2025

**Estimated Level of Effort:**

The estimated level of effort of the contract will be for 150 days.
