Amendment 001

This amendment is raised to answer questions that were received from Industry.

Question 1: Reference SR-28: Requirement is that vacuum systems to be suitable as vessel mounted while SR-27 requires all 6 units to be trailer mounted. Do you mean skid-mounted systems which are detachable from trailers or trailers are to be mounted on vessels? Are trailers also in the scope of supply for this contract?

Response 1: The Vacuum Systems are skid-mounted systems that can be secured to trailers and vessels via ISO corner fittings. Please refer to requirements SR-51, SR-52, SR-68, SR-57. Trailers are not in scope of supply for this contract.

Question 2: Reference SR-73: Shouldn't intake hose be 3" and discharge hose be 4"? What is the 6" nozzle for?

Response 2: The ports described in requirements SR-72 and SR-73 are all intake ports. The different sizes are requested for operator flexibility given that larger suction hoses enable higher recovery rates but are more difficult to handle. The 6 inch intake port is required to enable connection to a 6 inch inner diameter suction hose in the future if desired. The 6 inch suction hose is not in scope of supply for this contract.

Question 3: Reference S-51 & S-52: Please elaborate is this the detachable skid from the trailer or what?"

Response 3: Requirements SR-51 and SR-52 define the skid base that the vacuum system must be mounted on. The skid base will be used to secure the Vacuum System to a vessel or trailer via the ISO corner fittings defined in requirements SR-68 and SR-57.

Question 4: Reference SR-25: Please elaborate what is considered as a "safe distance for personnel" that vent line should discharge?

Response 4: *The requirement SR - 25 has been amended.*

Delete: SR - 25: The Vacuum System must include a solution which vents all toxic vacuum exhaust vapours to an area that is a safe distance from personnel operating the vacuum system.

Insert: SR - 25: The Vacuum System must include a solution that vents all vacuum exhaust vapours to an area located at least of 50 ft away from personnel operating the Vacuum System.

All other terms and conditions remain unchanged
