The Request for Proposal (RFP) Amendment 002 is raised to answer questions received from Bidders and includes an amendment.

QUESTIONS AND ANSWERS

Q4 - With respect to M.1.2 for both Workstream 1 and Workstream 2, item A asks for “at least 2 contracts, issued by an organization or group of organizations.” Could PSPC please clarify what is meant by “group of organizations”? Please confirm Bidders must submit two singular contracts, not large umbrella contracts such as TBIPS or TSPS used by a group of organizations.

A4 - The Bidder must have been directly awarded at least 2 contracts, issued by an organization or group of organizations in a government environment (for example, federal, provincial, municipal, state) private sectors are also acceptable

The contract for IT professional services must have had a minimum total value (including Applicable Taxes) to the Bidder of \$2,000,000 (in Canadian dollars); it does not need to be a TBIPS or TSPS as long as the task are clearly identified to match the categories in the RFP.

Q5 - With respect to M.1.3 and R.1.3 for both Workstream 1 and Workstream 2, the list of resource categories includes Levels and sometimes multiple levels. Could PSPC please confirm:

- a) Bidders may submit resources that are the same level or higher. For example, for Workstream 1 where it lists System Analyst, Level 2, Bidders can submit resources that were placed in the System Analyst, Level 3, category.
- b) Where two Levels are listed, it is sufficient to submit resources at one of the requested levels. For example, for Workstream 1 where it lists Application/Software Architect Level 2&3, Bidders can submit resources at either level, and are not required to demonstrate both levels on a single contract.

A5 -

- a) Yes, the bidders may submit resources that are the same level or higher.
- b) Yes, the bidders can submit resources at either level, and are not required to demonstrate both levels on a single contract but can on two separate contracts.

Q6 - With respect to M.1.3 and R.1.3 for both Workstream 1 and Workstream 2, it is unclear what PSPC expects in terms of the letter signed by the client:

- In the criteria item iv., the RFP states: For equivalent resource categories under a different title the Bidder must provide a letter signed by the client, or an email confirmation from the client, not by the Bidder, to certify that the tasks performed by the Resource Category (or Categories) and Level under each of the identified contract(s) include a minimum of 50% of the tasks identified in Article 3.2 of Annex A – Statement of Work;
- However in the Client Reference Form for M.1.3, the RFP states: The requirement to list at least 50 % of the Statement of Work tasks applies to the “equivalent resources” and does not apply to referenced contracts that include the same or higher level categories of the RFP. However a summary of the scope, resource categories provided and key responsibilities specific to the development of the Informatics professional services must be provided and supported by a letter signed by the client or an e-mail confirmation from the client and not by the bidder.

A) Could PSPC please confirm Bidders must have the information in criteria item iv signed by clients only for contracts where resources were placed under a different title (i.e. non-matching TBIPS categories)?

B) Are Bidders expected to get the additional information outlined in the Client Reference Form signed as well?

o If yes, and Bidders expected to get the information outlined in the Client Reference Form signed as well, could PSPC please confirm if we are required to get this information signed for all contracts, even if we are using direct-match TBIPS categories?

C) Specific to R.1.3, would PSPC accept client contact information in lieu of signed client letters, as well as implement the following clause in the RFP?

o Requests for Clarifications: If Canada seeks clarification or verification from the Bidder about client references in its bid, the Bidder will have five (5) working days (or a longer period if specified in writing by the Contracting Authority) to provide the necessary information to Canada. Failure to meet this deadline will result in the bid being declared non-responsive.

A6 -

a) I confirm that Bidders must have the information in criteria item iv signed by clients only for contracts where resources were placed under a different title (i.e. non-matching TBIPS categories)?

b) Yes Bidders are expected to get the additional information outlined in the Client Reference Form signed as well.

c) We will not accept references without a signed letter by the client.
