## **Solicitation Amendment No. 001**

### **Title: RISO Box Lunches**

This solicitation is hereby amended to:

- (1) Reference: **Closing date appearing of page one of the solicitation document**  
DELETE the closing date of **2022-03-04**; and  
INSERT the revised closing date of **2022-03-08**.
- (2) **Question 1** : Annexe A, page 2, "Costs of deposit, if applicable, must be identified as a separate item on the invoice", as opposed to "must be identified" . Can you please clarify if we need to add these costs to the invoices, if we don't pay a deposit until 2023?

**Answer 2** : As per Annex A , "All shipping charges must be included in the quoted prices. Applicable taxes must be excluded from the price. The cost of deposit for tetra paks or cans must also be excluded from quoted prices. Costs of Deposit, if applicable, must be identified as a separate item on the invoice."

If the cost of deposit is not applicable in your Province/City, this amount should be zero and there should no deposit cost added to the invoice. In the event that the regulation changes during the period of the standing offer, a notice should be sent to the standing offer authority.
