REFERENCE: Annex A Section 2.2.1 Onsite Restaurant

Q1: Are you able to more clearly define what is meant by "Onsite restaurant" in the requirement? For example, does the restaurant have to serve food for a minimum number of hours per day (ex. 8am – 10pm)? Does it have to serve breakfast, lunch, and dinner? Is there a required seating capacity? If there are any other details you could provide to best meet your needs please feel free to include them.

A1: The minimum requirement for the onsite restaurant is that it begins serving breakfast at no later than 0600h on weekdays.

DELETE: "2.2.1 Must have an onsite restaurant;"

INSERT: "2.2.1 Must have an onsite restaurant that begins serving breakfast at no later than 0600h on weekdays;"

Q2: In Annex B - Pricing Basis A - The dates for both the single occupancy (Item 1), double occupancy (Item 3), and parking (Item 3) from March 26 to April 16 have the number of nights listed as 35. To my understanding, given these dates, that would require a 21 night booking not 35. Are you able to clarify if the dates are correct or if the dates need to be changed?

A2: The number of nights is correct and the dates provided are incorrect. The correct dates and number of rooms are provided below, including an additional single room and parking space that have been added to the requirement.
