Would it be possible to clarify if the deliverable due on May 1 is a presentation (with slide deck submitted) or a report?
Answer 1	In all cases the contractor would propose their own method of best delivering the sought after information and materials listed in the SoW.

Question 2	If it is a report, what level of detail is expected and how would it differ from the Draft Final Report?
Answer 2	The Draft Final Report is merely a draft version of the report made available to Health Canada for review and comments. That review from HC will feed into the Final Report
