Amendment 006 has been raised to extend the solicitation closing date for the ongoing qualification period only and to publish all answers to questions received to-date.

A. SOLICITATION CLOSING DATE

Suppliers are reminded of the following:

To be included in the first round of evaluations, arrangements must be submitted electronically either through epost connect or Facsimile to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit, by the Initial Qualification Closing Date of MARCH 2, 2022 by 2:00 pm EST.

Arrangements submitted after this date will be kept for evaluation in subsequent rounds and so, the closing date is being extended indefinitely for the ongoing qualification of suppliers.

B. QUESTIONS AND ANSWERS

Q36. How do I know if you received my bid?

R36. All suppliers that submitted an arrangement will receive an email confirming that their bid has been received by the Supply Arrangement Authority within 2 weeks of the initial qualification closing date.

Q37. Is there a timeframe or date suppliers will be notified if they have been awarded a supply arrangement?

R37. All suppliers that submitted an arrangement will receive an email detailing whether or not their arrangement was successful. We cannot provide a timeframe for award, but as per subsection 5.4 of **2008**, Standard Instructions - Request for Supply Arrangements - Goods or Services, arrangements will remain open for acceptance for a period of not less than 180 days from the closing date of the RFSA, as amended in the RFSA at Article 2.1.
