The amendment to the bid solicitation is to address the enquiries received:

Response(s) (R) to Question(s) (Q)1:

- Q1. Can the work be done over more than one day each week?
R1. The weekly cleaning must occur in one day.
- Q2. Who provides the cleaning supplies and floor wax?
R2. This is the Contractor's responsibility. As per Annex A, Statement of Work, Scope of Work and Deliverables: "The Contractor must provide all labour, material, and supplies required to perform the Work including unforeseen work".
- Q3. Who supplies the toilet paper, paper towel and garbage bags?
R3. This is the Contractor's responsibility. As per Annex A, Statement of Work, Scope of Work and Deliverables: "The Contractor must provide all labour, material, and supplies required to perform the Work including unforeseen work".
- Q4. Is there a mileage rate payed?
R4. The Contractor is responsible for travel to and from the sites. The monthly and weekly rates proposed in Annex B, Basis of Payment are inclusive of travel.
- Q5. The 3 year contract, renewed annually, states a max dollar value of \$95,000. Is this the max amount per year or for the 3-year contract?
R5. As per the Mandatory Financial Criteria: "The maximum budget allocated for this project must not exceed \$95,000.00 applicable taxes extra, including option periods, all labour, associated costs and subcontractors".
This is a total of five years, (two firm years plus three one-year option periods).
