Weapon Effects Simulation Modernization (WESM) Industry Day

Canada will host a non-mandatory Industry Day, which interested suppliers are encouraged to attend. Due to the Covid Pandemic, this Industry Day event is scheduled to take place virtually on MS Teams on **Tuesday, April 12, 2022, from 11:00 to 13:00 EST**. Any changes to this date and time will be followed up with a subsequent amendment issued against this RFI.

Suppliers who choose to attend must submit a confirmed list of attending representatives to the Contracting Authority listed for this RFI, including name and company title. The confirmed list of attending representatives is to be submitted no later than **April 5, 2022**.

Canada will send all attending suppliers the official event agenda and presentation shortly before the event. This information will be posted as well on Buy and Sell after the Industry Day. Canada will provide a presentation on the Project, and a Questions and Answers session will be held. Attendance to the event is not mandatory, and will not prevent potential suppliers from bidding on any possible future solicitations.

Any exchange of information during Industry Day, including Questions and Answers deemed to be of significant value to suppliers may be provided to non-attendees on Buy and Sell via an amendment to this RFI.

Canada will not be responsible for any costs associated with Industry's attendance at the virtual Industry Day.

WESM One-on-One Sessions

Canada will host optional One-on-One sessions with interested Industry Participants. Due to the Covid Pandemic, the One-on-One sessions will take place virtually beginning immediately after the Industry Day presentation on Wednesday, April 13, 2022, up to Thursday, April 21, 2022 (if needed).

The One-on-One meetings will allow the potential Industry participants to present their solutions, identify concerns, and pose their questions. While the Government participants do not plan to provide any new information during the One-on-One meetings, any new information discussed will be posted for all potential bidders to view through an amendment to this RFI, unless it is deemed Commercial Confidential and then nothing will be published. Canada may request further consultations with any suppliers at any time during this RFI period, in order to obtain clarification on feedback received. Sessions will be for a maximum period of two hours each. Interested suppliers must indicate their interest by submitting the names and titles of each company representative to the Contracting Authority named in this RFI no later than **April 5, 2022**. Suppliers may submit questions prior to their individual One-on-One session.

Time slots will be awarded to each interested company based on a first come first served basis, which will be confirmed in writing back by the Contracting Authority. In case of conflict, please indicate in your request your first, second and third-choice time slot.
