QUESTION AND ANSWER – SERIES III

Q13. At what phase is Camp Sustain in the Project Process?

A13. Camp Sustain is in the early stages of Options Analysis.

Q14. Would Canada consider including other capabilities to Camp Sustain, such as, but not limited to, the following: medical/dental center, ammunition storage, guardroom gate security, firefighting facility, UAV facility, kennels, sensitive compartmented Information Facility, Tethered Balloon and Small Arms Trainer facility?

A14. Canada will consider all technical capabilities, infrastructure and solutions, and procurement and sustainment strategies identified above.

The Technical Requirement(s), Procurement and Sustainment Strategies and applicability of the ITB Policy, including Value Proposition (VP), have not yet been determined. Canada will confirm, define and identify all of the aforementioned following internal and industry consultations at a later stage. Once determined, industry will be notified on Buy and Sell through an amendment to the RFI.

Q15. Would Canada consider including other infrastructure to Camp Sustain that would require power, such as, but not limited to, the following: helicopter landing site, protected walkways, perimeter security lighting, vehicle park and shooting range?
