A) Questions and Answers

Q1. Item B.1.5 states that 10 points will be awarded for Pilots who have completed a Parks Canada Rescue Pilot evaluation within the last 10 years. Does this include active PC Mountain Rescue pilots who may have been tested 20+ years ago?

A1. Yes. Pilots who have been an approved rescue pilot within the last 10 years, including those who are currently active yet completed their evaluation more than 10 years ago would be acceptable.

B) Amend ANNEX F – TECHNICAL EVALUATION
