PART 1 - GENERAL INFORMATION

1.1 Statement of Requirement

1.1.1 The requirement is detailed under Annex "A" of the resulting contract clauses.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.3 epost Connect service

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

2.1 Standard Instructions, Clauses and Conditions

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 5 (FIVE) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Newfoundland and Labrador.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Bid Challenge and Recourse Mechanisms

- (a) Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.
- (b) Canada encourages suppliers to first bring their concerns to the attention of the Contracting Authority. Canada's [Buy and Sell](#) website, under the heading "[Bid Challenge and Recourse Mechanisms](#)" contains information on potential complaint bodies such as:

3.1 Bid Preparation Instructions

If there is a discrepancy between the wording of the soft copy on electronic media and the hard copy, the wording of the hard copy will have priority over the wording of the soft copy.

- If the Bidder is simultaneously providing copies of its bid using multiple acceptable delivery methods, and if there is a discrepancy between the wording of any of these copies and the electronic copy provided through epost Connect service, the wording of the electronic copy provided through epost Connect service will have priority over the wording of the other copies.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of hard copy of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process [Policy on Green Procurement](https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=32573) (<https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=32573>). To assist Canada in reaching its objectives, bidders should:

- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

- 1.1** The intent of this Technical Statement of Requirements (TSOR) shall be to supply a new Anchor Windlass for CCGS Cygnus.

Part 3: Mandatory Requirements:

- 3.1** Anchor windlass must be hydraulically driven. Hydraulic power will be supplied from the vessels' current deck hydraulic system. System operates at a max pressure of 2500 psi and max flow rate of 35gpm.
- 3.2** Total anchor windlass weight shall not exceed 7200lbs.
- 3.3** Nominal footprint for the windlass shall be capable of bolting to existing windlass bedplate as shown in drawing 97037-37 Anchor Windlass Seat . 'Anchor Windlass Seat, drawing No. 97037-37 is for reference only to show current arrangement fitted. Successful bidder is required to perform a site visit to the CCGS Cygnus in NL to confirm their proposal will fit and properly function with current arrangement of spurling pipes, hawse pipes and chain rollers.
- 3.4** Vendor to supply a minimum of 50 mounting bolts of proper size and grade to bolt new windlass to existing bedplate.
- 3.5** Anchor windlass shall be capable of weighing 2 anchors of 2535 lbs each, along with their respective chains, 7 shots port and 8 shots stbd, approx. 1200lb/shot.
- 3.6** The two (2) anchor chains are 30 mm stud link, Grade U3.
- 3.7** Anchor windlass shall have a "Wildcat" with a Nominal performance of at least at 11 tonnes @ 9.5 m/min, a high speed of at least 5.5 tonnes at 19 m/min. Windlass shall be capable of an overload condition of 150% for minimum of 2 mins. Brake Capacity of at least 23.2 tonnes.

-
- 3.8** A “Devils Claw” arrangement shall be fitted to the windlass, on both sides, to act as a “locking” arrangement. It shall be of sufficient size to fit the anchor chain.
- 3.9** Anchor windlass “Wildcats” shall be capable of dual speed control, one of low speed/high torque (minimum 9.5m/min) and one of high speed/low torque (minimum 19m/min), both at nominal pull.
- 3.10** “Wildcats” shall be mounted on “bronze” bushings, fitted with grease ways that allow for good distribution of grease along bushing surfaces. Grease fittings shall be installed that allow ease of greasing by operator.
- 3.11** Anchor windlass shall be fitted with two (2) independently operated “Warping Drums” capable of operation without the “Wildcats”, i.e. a manually activated locking clutch arrangement. “Warping Drums” shall be in the range of 16” to 18” diameter and capable of dual speed, same speeds as indicated for “Wildcats”.
- 3.12** All moving parts shall be fitted with grease fittings that are easily accessible and clearly identified.
- 3.13** The gearbox of the anchor windlass shall be fitted with the following: a means of checking the oil level, a fill plug, a drain connection c/w drain valve, inspection cover(s) allowing visual inspection of the gear drive.
- 3.14** A deck mounted, waterproof, corrosion resistant enclosure must be included and contain the following: 1) start/stop controls, 2) speed control, 3) power available lamp, 4) running lamp, and 5) e-stop. All lamps to be LED. All controls to be capable of 120v power operation. All lamps and controls to be IP67 rated.
- 3.15** Control panel must be situated as such to allow for operation of anchor windlass from either port or stbd side of unit.
- 3.16** Anchor windlass design shall be such as to allow for dropping of the anchors without hydraulic power being available.
- 3.17** Anchor windlass shall be protected with a Marine Grade epoxy paint, “buff” in color, to help prevent corrosion of the unit.
- 3.18** Anchor windlass and components shall be ABS Classification Society Approved Marine Design and appropriate certificates shall be provided with unit.
- 3.19** Three (3) illustrated copies of the Installation, Operation and Maintenance manuals shall be included along with one (1) digital copy on USB drive.
- 3.20** Vendor shall include in their bid the cost of providing installation drawing for the proposed anchor windlass.
- 3.21** Anchor windlass shall carry a 12 month warranty, effective from date of commissioning by the Field Service Representative (FSR).
- 3.22** Anchor windlass supplier shall be Canadian and capable of supplying a FSR within 12 hrs.
- 3.23** Anchor Windlass and associated equipment shall be ready for supply within 6 months of contract award date but not before April 7 2022. Once ready for delivery anchor windlass

shall be delivered to Canadian Coast Guard Technical Stores, 280 Southside Rd, St John's, NL.

- 3.24** Bidding vendor shall provide in their proposal proof of meeting Part 3: Mandatory Requirements, Part 4: Proof of Performance and Part 5: Deliverables. It is recommended that the vendor respond to each section of this document and clearly state or show that its requirements are understood and met. Failure to clearly demonstrate compliance may result in the bid being rejected.

Part 4: Proof of Performance:

4.1 Testing

4.1.1. Vendor shall include in their bid travel to St. John's, NL to complete commissioning / testing of installed Anchor Windlass and to provide training / familiarization to both crews of the vessel. Vendor shall allow for two (2), twelve (12) hr days onboard vessel for commissioning and training.

4.1.2. Vendor shall provide ABS Classification Society Survey certificate which shall include Anchor Windlass serial number and order number.

Part 5: Deliverables:

5.1 Delivery

5.1.1 Vendor shall include in their bid fixed price and rates for two (2), twelve (12) hour days on board as per 4.1.1 for commissioning of installed Anchor Windlass along with providing training / familiarization to vessels crew. This bid shall include travel and lodging for said period as well.

5.2 Spares

5.2.1. Vendor shall include, as part of their bid, a set of "wearable" spares, such as, but not limited to, brake linings (2 sets), bronze bushings (2 complete sets), and fuses for control panel. Vendor shall also provide an itemized list of recommended spare parts/tools to be maintain onboard vessel and include individual price per item.

5.3 Training

5.3.1. Vendor shall include in their bid travel to St. John's, NL to complete commissioning of installed Anchor Windlass along with providing training / familiarization to vessels crew. Travel and lodging shall be included in their bid and in accordance with the National Joint Council Travel Directive.

5.4.1. Vendor shall supply Installation, Maintenance and Operating manuals. Three (3) copies along with one (1) set on USB drive.
