Please clarify the difference within the specifications for Mandatory Technical Criteria 1&2 where it states that:

1. The bidder must provide in writing a list of 5 years of experience in Commercial Duct Cleaning, and
2. The Bidder must provide details of two (2) Duct Cleaning Contracts within the last 5 years

Answers:

1. The list of 5 years' experience in Commercial Duct Cleaning is to prove that the bidder's company has been in the Commercial Duct Cleaning industry for at least 5 years and has experience in Commercial Duct Cleaning; this list must show the dates of Commercial Duct Cleaning jobs.

2. The details of two (2) Duct Cleaning Contracts within the last 5 years is to provide the specific details of Duct Cleaning Contracts, as per ANNEX G (Duct Cleaning Contractor Qualification Attestation Form) of the Request For a Standing Offer. The information provided in ANNEX G could be easily verified. The two (2) Duct Cleaning Contracts within the last 5 years may also be listed in the list of 5 years' experience in Commercial Duct Cleaning.
