1. QUESTIONS AND ANSWERS

1. Question 1

Can de Canadian Coast Guard (CCG) give in front the colors and amount of lanterns per type, per call-up for the duration of the tender?

Answer 1

The CCG cannot know at this time the colors and the amount of lanterns **per call-up**, as there are over 1700 navigation aids sites in Canada, each of them with different needs in terms of quantity, intensity, angle of divergence, colour, etc. Each of these sites is independent and there are 6 different administrative regions.

The CCG can however estimate the below breakdown of the **entire Standing Offer quantity** (aprox. 500), which would be:

- Color breakdown: 35% green, 35% red, 30% yellow, and 10% white, regardless of category.
- Quantity breakdown per type of lantern:
 - Type 1 : 50
 - Type 2 : 70
 - Type 3 : 260
 - Type 4 : 140

2. Question 2

Could the delivery time of 6 weeks after a call-up been extended to 16 weeks?

Answer 2

We understand the actual challenges that the industry is facing regarding the lead time for certain components. This is the reason why we are replacing the 6 weeks delivery time with 16 weeks.
