Question #1

Mandatory requirement MT7 (page 10) states that ISO 9001 certification is mandatory. Will ISO 17025 certification, along with a submission of a quality manual, be considered acceptable?

Answer #1

No. ISO 17025 certification is not acceptable. ISO 9001 certification is mandatory.

Question #2

Is there a preferred ASTM method for Soot content measurement (by Fourier Transform Infrared)?

Answer #2

Soot is not a mandatory or special test required for this RFP. This is listed in the Appendix II to Annex A, file format for OCCAP data, but it will remain as an unpopulated field.

Question #3

Is it possible to extend the RFP deadline by one week?

Answer #3

The RFP was previously extended to close at 14:00 EDT on 25 March, 2022.

Question #4

In Part 5 - Certifications and Additional Information, Section 5.1 Certifications Required with the Bid, Sub Section 5.1.1 A3051T (2018-12-06) Canadian Content Certification, it stated that we must submit this certification with our bid. What should be submitted to satisfy this requirement?

Answer #4

There was an error in the RFP and has been corrected in this RFP amendment #003. In regard to Subsection 5.1.1, Canadian Content Certification is amended as follows.

DELETE:

5.1 Certifications Required with the Bid

Bidders must submit the following duly completed certifications as part of their bid.

5.1.1 A3051T (2018-12-06) Canadian Content Certification

Bidders should submit this certification completed with their bid. If the certification is not completed and submitted with the bid, the Contracting Authority will so inform the Bidder
