Request for Proposal – Department of National Defence (DND) Requirement – Smoke Generator, (hereinafter referred to as a "Smoke Pot – 3 Minute White", or "Smoke Pot")

The subject Request for Proposal, (RFP), is amended as detailed below. This amendment to the RFP includes the following:

- The replacement of a corrupted electronic file in the English version of RFP Amendment 003.

The full text of RFP Amendment 003 is presented below:

"

Request for Proposal – Department of National Defence (DND) Requirement – Smoke Generator, (hereinafter referred to as a "Smoke Pot – 3 Minute White", or "Smoke Pot")

The subject Request for Proposal, (RFP), is amended as detailed below. This amendment to the RFP includes the following:

- Publication of questions submitted by potential bidders and answers to the submitted questions; and,
- Modifications to the Request for Proposal.

1.0 Questions and Answers

- Question 1: Will DND accept goods that require modification or development post contract award, in order to meet the identified specifications?
- Answer 1: No. This bid solicitation has been drafted on the basis of there being goods currently available within the marketplace which meet the stated specifications. To clarify this point, the bid solicitation is amended herein to state that the proposed goods must be an existing and commercially available product meeting all evaluation criteria at time of bidding.
- Question 2: The environmental requirements for the Smoke Pot obligate it to have a waterproof body. We have a proposed approach/design for meeting this requirement. Can DND advise on the acceptability of the proposed approach/design ?
- Answer 2: In order to maintain equal treatment of potential bidders within the competitive bidding process, DND is unable to advise bidders on the acceptability of a proposed solution. Following bid closing, bids will be evaluated in accordance with the Mandatory Technical Criteria.
- Question 3: We have access to a product which has a burn time of 160 seconds +/- 30 seconds. Would this be acceptable ?
- Answer 3: Yes. Under Evaluation Item "A4" of the Compliance Verification Matrix , the proposed goods must have a burn time of 3 minutes (180 seconds) with a margin of error of +/- 30 seconds. Please note that Evaluation Item "A4" has been revised below to state the burn time requirement as being a nominal burn time for the proposed goods, which must be between 150 and 210 seconds.

Question 4:	As the Mandatory Technical Criteria require that justifications, as detailed in Column 4 of the Compliance Verification Matrix are to be provided at time of bidding, it is assumed that the development of goods within the required delivery period will not be considered. Is this correct ?
Answer 4:	Correct. As indicated in response A1 above, the proposed goods must be an existing and commercially available product meeting all evaluation criteria at time of bidding.
Question 5:	Do RFP's for this requirement come up yearly ?
Answer 5:	The requirement for the supply of Smoke Pots to DND is a recurring requirement, and is competed approximately every five (5) years, depending on usage and shelf life.

"4.1.1.1 Mandatory Technical Criteria

The Bidder must comply with the following mandatory technical criteria:

- At time of bidding, the Bidder's proposed goods must be an existing and commercially available product meeting all of the mandatory requirements detailed in Column 3 of the Compliance Verification Matrix, included at Annex A of Attachment 1 to Part 3 of the bid solicitation; and,
- The Bidder must provide all of the required justifications, as detailed in Column 4 of the Compliance Verification Matrix, included at Annex A of Attachment 1 to Part 3 of the bid solicitation.

The Phased Bid Compliance Process will apply to all mandatory technical criteria.

Bids which do not meet all mandatory requirements will be declared non responsive.
