## Amendment 001

The following is hereby amended:

- A. Answer questions from Bidders;

### A. QUESTIONS AND ANSWERS

Q1. According to the technical specifications, in the paragraph below mentioned in parenthesis, regarding the floor treatment, it is specified "cleaning and waxing". We want to make sure that the real need is not a stripping and waxing.

(Following an agreement with the Contractor, the Agency will take the necessary measures to move filing cabinets and heavy objects or furniture to allow cleaning and waxing in these areas, once a year).

A1. Yes, the correct need is a stripping and waxing. There was an error in the term used. Therefore, at Annex A – Statement of Work, item 2.4 Technical Specifications, **REPLACE** the term "cleaning" **WITH** "stripping" in the paragraph below;

"Upon agreement with the Contractor, the Agency shall arrange for the relocation of filing cabinets and heavy objects or furniture to make stripping and waxing possible at these locations once a year."
