PART 1 - GENERAL INFORMATION

1.1 Security Requirements

1.1.1 Before award of a contract, the following conditions must be met:

- (a) the Bidder must hold a valid organization security clearance as indicated in Part 6 - Resulting Contract Clauses;
- (b) the Bidder's proposed individuals requiring access to classified or protected information, assets or sensitive work sites must meet the security requirements as indicated in Part 6 - Resulting Contract Clauses;
- (c) the Bidder must provide the name of all individuals who will require access to classified or protected information, assets or sensitive work sites.

1.1.2 Bidders are reminded to obtain the required security clearance promptly. Any delay in the award of a contract to allow the successful Bidder to obtain the required clearance will be at the entire discretion of the Contracting Authority.

1.1.3 For additional information on security requirements, Bidders should refer to the Contract Security Program of Public Works and Government Services Canada (<http://www.tpsgc-pwgsc.gc.ca/esc-src/introduction-eng.html>) website.

1.2 Statement of Work

The Work to be performed is detailed under Annex B.

1.3 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.4 Trade Agreements

The requirement is subject to the provisions of the World Trade Organization-Agreement on Government Procurement (WTO-AGP), the Canada-Chile Free Trade Agreement (CCFTA), the Canadian Free Trade Agreement (CFTA), the Canada-Peru Free Trade Agreement (CPFTA), the Canada-Columbia Free Trade Agreement (CColFTA), the Canada-Panama Free Trade Agreement (CPanFTA), the Canada-Honduras Free Trade Agreement (CHFTA), the Canada-Korea Free Trade Agreement (CKFTA), the Comprehensive and Progressive Agreement for the Trans-Pacific (CPTTP), the Canada-Europe Union Comprehensive Economic and Trade Agreement (CETA), and the Canada – Ukraine FTA.)

1.5 COVID-19 Vaccine Requirement

This requirement is subject to the COVID-19 Vaccination Policy for Supplier Personnel. Failure to complete and provide the COVID-19 Vaccination Requirement Certification as part of the bid will render the bid non-responsive.

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the Standard Acquisition Clauses and Conditions Manual (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2020-05-28) Standard Instructions – Goods and Services – Competitive Requirements, are incorporated by reference into and form part of the bid solicitation, with the following modifications:

- a) Section 02, Procurement Business Number is deleted in its entirety.
- b) Section 20(2), Further Information is deleted in its entirety.
- c) Subsection 2.d. of Section 05, Submission of Bids, is deleted in its entirety and replaced with the following:

Send its bid only to the address specified in the bid solicitation.

- d) Section 06, Late Bids, Is deleted in its entirety;
- e) The text under Section 07, Delayed Bids, is deleted in its entirety and replaced with the following:

It is the Bidder's responsibility to ensure that the Contracting Authority has received the entire submission. Misrouting or other electronic delivery issues resulting in late submission of bids will not be accepted.
- f) Subsection 1 of Section 08, Transmission by Facsimile and epost connect is deleted in its entirety.

Subsection 5.4 of 2003, Standard Instructions - Goods or Services –Competitive Requirements, is amended as follows:

Delete: 60 days
Insert: 120 days

2.2 Electronic Submission of Bids

- a) Bids must be submitted only to the Department of National Defence by the date, time and place indicated on page 1 of the bid solicitation. Bids must be received electronically as noted in subparagraph b).
- b) **Electronic Submissions: Individual e-mails exceeding five (5) megabytes, or that includes other factors such as embedded macros and/or links, may be rejected by the DND e-mail system and/or firewall(s) without notice to the Bidder or Contracting Authority.** Larger bids may be submitted through more than one e-mail. The Contracting Authority will confirm receipt of documents. It is the Bidder's responsibility to ensure that the Contracting Authority has received the entire submission. Bidders should not assume that all documents have been received unless the Contracting Authority confirms receipt of each document. In order to minimize the potential for

technical issues, Bidders are requested to allow sufficient time before the closing time and date to confirm receipt. Technical and financial documents received after the closing time and date will not be accepted.

Due to the nature of the bid solicitation, bids transmitted by facsimile and epost Connect will not be accepted.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 5 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in **Ontario**.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

Canada requests that Bidders provide their bid in separately bound sections as follows:

- Section I: Technical Bid (1 Electronic copy)
- Section II: Financial Bid (1 Electronic copy)
- Section III: Certifications (1 Electronic copy)
- Section IV: Additional Information (1 Electronic copy)

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Bidders may use Annex "D" to indicate their prices. If Bidders choose to use Annex "D" to indicate their prices, Bidders must include Annex "D" in their financial bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) format;
- (b) use a numbering system that corresponds to the bid solicitation.

Section I: Technical Bid

In their technical bid, Bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

Section II: Financial Bid

Bidders must submit their financial bid as follows:

Bidders must submit firm prices, delivered Delivery Duty Paid (DDP) at **Petawawa, ON** Incoterms 2010 as indicated in Annex "D" Pricing Schedule, Applicable Taxes excluded. The total amount of Applicable Taxes must be shown separately, and;

Bidders must submit firm prices, Free Carrier (FCA) at **Contractor's Facility** Incoterms 2010 as indicated in Annex "D" Pricing Schedule, Applicable Taxes excluded. The total amount of Applicable Taxes must be shown separately.

Unless the bid solicitation specifically requires bids to be submitted in Canadian currency, bids submitted in foreign currency will be converted to Canadian currency for evaluation purposes. The rate given by the Bank of Canada in effect on the bid solicitation closing date, or on another date specified in the bid solicitation, will be applied as a conversion factor to the bids submitted in foreign currency.

3.1.1 Electronic Payment of Invoices – Bid

If you are willing to accept payment of invoices by Electronic Payment Instruments, complete APPENDIX 1 to PART 3 Electronic Payment Instruments, to identify which ones are accepted.

If APPENDIX 1 to PART 3 Electronic Payment Instruments is not completed, it will be considered as if Electronic Payment Instruments are not being accepted for payment of invoices.

Acceptance of Electronic Payment Instruments will not be considered as an evaluation criterion.

Section III: Certifications

Bidders must submit the certifications and additional information required under Part 5.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.
- (c) Canada will use the Phased Bid Compliance Process described below.

4.1.1 Phased Bid Compliance Process

4.1.1.1 (2018-07-19) General

- (a) Canada is conducting the PBCP described below for this requirement.
- (b) Notwithstanding any review by Canada at Phase I or II of the PBCP, Bidders are and will remain solely responsible for the accuracy, consistency and completeness of their Bids and Canada does not undertake, by reason of this review, any obligations or responsibility for identifying any or all errors or omissions in Bids or in responses by a Bidder to any communication from Canada.

THE BIDDER ACKNOWLEDGES THAT THE REVIEWS IN PHASE I AND II OF THIS PBCP ARE PRELIMINARY AND DO NOT PRECLUDE A FINDING IN PHASE III THAT THE BID IS NON-RESPONSIVE, EVEN FOR MANDATORY

REQUIREMENTS WHICH WERE SUBJECT TO REVIEW IN PHASE I OR II AND NOTWITHSTANDING THAT THE BID HAD BEEN FOUND RESPONSIVE IN SUCH EARLIER PHASE. CANADA MAY DEEM A BID TO BE NON-RESPONSIVE TO A MANDATORY REQUIREMENT AT ANY PHASE.

THE BIDDER ALSO ACKNOWLEDGES THAT ITS RESPONSE TO A NOTICE OR A COMPLIANCE ASSESSMENT REPORT (CAR) (EACH DEFINED BELOW) IN PHASE I OR II MAY NOT BE SUCCESSFUL IN RENDERING ITS BID RESPONSIVE TO THE MANDATORY REQUIREMENTS THAT ARE THE SUBJECT OF THE NOTICE OR CAR, AND MAY RENDER ITS BID NON-RESPONSIVE TO OTHER MANDATORY REQUIREMENTS.

- (c) Canada may, in its discretion, request and accept at any time from a Bidder and consider as part of the Bid, any information to correct errors or deficiencies in the Bid that are clerical or administrative, such as, without limitation, failure to sign the Bid or any part or to checkmark a box in a form, or other failure of format or form or failure to acknowledge; failure to provide a procurement business number or contact information such as names, addresses and telephone numbers; inadvertent errors in numbers or calculations that do not change the amount the Bidder has specified as the price or of any component thereof that is subject to evaluation. This must not limit Canada's right to request or accept any information after the bid solicitation closing in circumstances where the bid solicitation expressly provides for this right. The Bidder will have the time period specified in writing by Canada to provide the necessary documentation. Failure to meet this deadline will result in the Bid being declared non-responsive.
- (d) The PBCP does not limit Canada's rights under Standard Acquisition Clauses and Conditions (SACC) 2003 (2020-05-28) Standard Instructions – Goods or Services – Competitive Requirements nor Canada's right to request or accept any information during the solicitation

period or after bid solicitation closing in circumstances where the bid solicitation expressly provides for this right, or in the circumstances described in subsection (c).

- (e) Canada will send any Notice or CAR by any method Canada chooses, in its absolute discretion. The Bidder must submit its response by the method stipulated in the Notice or CAR. Responses are deemed to be received by Canada at the date and time they are delivered to Canada by the method and at the address specified in the Notice or CAR. An email response permitted by the Notice or CAR is deemed received by Canada on the date and time it is received in Canada's email inbox at Canada's email address specified in the Notice or CAR. A Notice or CAR sent by Canada to the Bidder at any address provided by the Bidder in or pursuant to the Bid is deemed received by the Bidder on the date it is sent by Canada. Canada is not responsible for late receipt by Canada of a response, however caused.

4.1.1.2 (2018-03-13) Phase I: Financial Bid

- (a) After the closing date and time of this bid solicitation, Canada will examine the Bid to determine whether it includes a Financial Bid and whether any Financial Bid includes all information required by the solicitation. Canada's review in Phase I will be limited to identifying whether any information that is required under the bid solicitation to be included in the Financial Bid is missing from the Financial Bid. This review will not assess whether the Financial Bid meets any standard or is responsive to all solicitation requirements.
- (b) Canada's review in Phase I will be performed by officials of the Department of National Defence.
- (c) If Canada determines, in its absolute discretion that there is no Financial Bid or that the Financial Bid is missing all of the information required by the bid solicitation to be included in the Financial Bid, then the Bid will be considered non-responsive and will be given no further consideration.
- (d) For Bids other than those described in c), Canada will send a written notice to the Bidder ("Notice") identifying where the Financial Bid is missing information. A Bidder, whose Financial Bid has been found responsive to the requirements that are reviewed at Phase I, will not receive a Notice. Such Bidders must not be entitled to submit any additional information in respect of their Financial Bid.
- (e) The Bidders who have been sent a Notice must have the time period specified in the Notice (the "Remedy Period") to remedy the matters identified in the Notice by providing to Canada, in writing, additional information or clarification in response to the Notice. Responses received after the end of the Remedy Period will not be considered by Canada, except in circumstances and on terms expressly provided for in the Notice.
- (f) In its response to the Notice, the Bidder will be entitled to remedy only that part of its Financial Bid which is identified in the Notice. For instance, where the Notice states that a required line item has been left blank, only the missing information may be added to the Financial Bid, except that, in those instances where the addition of such information will necessarily result in a change to other calculations previously submitted in its Financial Bid, (for example, the calculation to determine a total price), such necessary adjustments must be identified by the Bidder and only these adjustments must be made. All submitted information must comply with the requirements of this solicitation.
- (g) Any other changes to the Financial Bid submitted by the Bidder will be considered to be new information and will be disregarded. There will be no change permitted to any other Section of

the Bidder's Bid. Information submitted in accordance with the requirements of this solicitation in response to the Notice will replace, in full, **only** that part of the original Financial Bid as is permitted above, and will be used for the remainder of the bid evaluation process.

- (h) Canada will determine whether the Financial Bid is responsive to the requirements reviewed at Phase I, considering such additional information or clarification as may have been provided by the Bidder in accordance with this Section. If the Financial Bid is not found responsive for the requirements reviewed at Phase I to the satisfaction of Canada, then the Bid must be considered non-responsive and will receive no further consideration.
- (i) Only Bids found responsive to the requirements reviewed in Phase I to the satisfaction of Canada, will receive a Phase II review.

4.1.1.3 (2018-03-13) Phase II: Technical Bid

- (a) Canada's review at Phase II will be limited to a review of the Technical Bid to identify any instances where the Bidder has failed to meet any Eligible Mandatory Criterion. This review will not assess whether the Technical Bid meets any standard or is responsive to all solicitation requirements. Eligible Mandatory Criteria are all mandatory technical criteria that are identified in this solicitation as being subject to the PBCP. Mandatory technical criteria that are not identified in the solicitation as being subject to the PBCP, will not be evaluated until Phase III.
- (b) Canada will send a written notice to the Bidder (Compliance Assessment Report or "CAR") identifying any Eligible Mandatory Criteria that the Bid has failed to meet. A Bidder whose Bid has been found responsive to the requirements that are reviewed at Phase II will receive a CAR that states that its Bid has been found responsive to the requirements reviewed at Phase II. Such Bidder must not be entitled to submit any response to the CAR.
- (c) A Bidder must have the period specified in the CAR (the "Remedy Period") to remedy the failure to meet any Eligible Mandatory Criterion identified in the CAR by providing to Canada in writing additional or different information or clarification in response to the CAR. Responses received after the end of the Remedy Period will not be considered by Canada, except in circumstances and on terms expressly provided for in the CAR.
- (d) The Bidder's response must address only the Eligible Mandatory Criteria listed in the CAR as not having been achieved, and must include only such information as is necessary to achieve such compliance. Any additional information provided by the Bidder which is not necessary to achieve such compliance will not be considered by Canada, except that, in those instances where such a response to the Eligible Mandatory Criteria specified in the CAR will necessarily result in a consequential change to other parts of the Bid, the Bidder must identify such additional changes, provided that its response must not include any change to the Financial Bid.
- (e) The Bidder's response to the CAR should identify in each case the Eligible Mandatory Criterion in the CAR to which it is responding, including identifying in the corresponding section of the original Bid, the wording of the proposed change to that section, and the wording and location in the Bid of any other consequential changes that necessarily result from such change. In respect of any such consequential change, the Bidder must include a rationale explaining why such consequential change is a necessary result of the change proposed to meet the Eligible Mandatory Criterion. It is not up to Canada to revise the Bidder's Bid, and failure of the Bidder to do so in accordance with this subparagraph is at the

Bidder's own risk. All submitted information must comply with the requirements of this solicitation.

- (f) Any changes to the Bid submitted by the Bidder other than as permitted in this solicitation, will be considered to be new information and will be disregarded. Information submitted in accordance with the requirements of this solicitation in response to the CAR will replace, in full, **only** that part of the original Bid as is permitted in this Section.
- (g) Additional or different information submitted during Phase II permitted by this section will be considered as included in the Bid, but will be considered by Canada in the evaluation of the Bid at Phase II only for the purpose of determining whether the Bid meets the Eligible Mandatory Criteria. It will not be used at any Phase of the evaluation to increase any score that the original Bid would achieve without the benefit of such additional or different information. For instance, an Eligible Mandatory Criterion that requires a mandatory minimum number of points to achieve compliance will be assessed at Phase II to determine whether such mandatory minimum score would be achieved with such additional or different information submitted by the Bidder in response to the CAR. If so, the Bid will be considered responsive in respect of such Eligible Mandatory Criterion, and the additional or different information submitted by the Bidder must bind the Bidder as part of its Bid, but the Bidder's original score, which was less than the mandatory minimum for such Eligible Mandatory Criterion, will not change, and it will be that original score that is used to calculate any score for the Bid
- (h) Canada will determine whether the Bid is responsive for the requirements reviewed at Phase II, considering such additional or different information or clarification as may have been provided by the Bidder in accordance with this Section. If the Bid is not found responsive for the requirements reviewed at Phase II to the satisfaction of Canada, then the Bid must be considered non-responsive and will receive no further consideration.
- (i) Only Bids found responsive to the requirements reviewed in Phase II to the satisfaction of Canada, will receive a Phase III evaluation.

4.1.1.4 (2018-03-13) Phase III: Final Evaluation of the Bid

- (a) In Phase III, Canada will complete the evaluation of all Bids found responsive to the requirements reviewed at Phase II. Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) A Bid is non-responsive and will receive no further consideration if it does not meet all mandatory evaluation criteria of the solicitation.

4.1.2 Technical Evaluation

The technical evaluation will be carried out as per Appendix 1 to Part 4 Technical Evaluation Criteria.

4.1.2.1 Mandatory Technical Criteria

Bidders must meet all mandatory technical evaluation criteria detailed in Appendix 1 to Part 4. The Phased Bid Compliance Process will apply to all mandatory technical criteria.

4.1.2.2 Financial Evaluation

The price of the bid will be evaluated in Canadian dollars, Delivered Duty Paid (DDP) at **Petawawa, ON** Incoterms 2010, Canadian customs duties and excise taxes included, Applicable Taxes excluded.

Canada reserves the right to award the Contract either FCA (**Contractor's shipping point**) or DDP **Petawawa, ON**).

4.2 Basis of Selection

4.2.1 Basis of Selection – Highest Combined Rating of Technical Merit and Price

1. To be declared responsive, a bid must:
 - a. comply with all the requirements of the bid solicitation; and
 - b. meet all mandatory criteria; and
 - c. obtain the required minimum of 50 points overall for the technical evaluation criteria which are subject to point rating.
 - d. The rating is performed on a scale of 100 points.
2. Bids not meeting (a) or (b) or (c) will be declared non-responsive.
3. The selection will be based on the highest responsive combined rating of technical merit and price. The ratio will be 50 % for the technical merit and 50% for the price.
4. To establish the technical merit score, the overall technical score for each responsive bid will be determined as follows: total number of points obtained / maximum number of points available multiplied by the ratio of 50%.
5. To establish the pricing score, each responsive bid will be prorated against the lowest evaluated price and the ratio of 50%.
6. For each responsive bid, the technical merit score and the pricing score will be added to determine its combined rating.
7. Neither the responsive bid obtaining the highest technical score nor the one with the lowest evaluated price will necessarily be accepted. The responsive bid with the highest combined rating of technical merit and price will be recommended for award of a contract.

The table below illustrates an example where all three bids are responsive and the selection of the contractor is determined by a 50/50 ratio of technical merit and price, respectively. The total available points equals 100 and the lowest evaluated price is \$45,000.

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

6.4 Term of Contract

6.4.1 Period of the Contract

The period of the Contract is from date of Contract Award to 12 months following Contract Award, inclusive.

6.4.2 Delivery Date

All the Goods deliverables must be received within 10 weeks following Contract Award Date.

6.4.2.1 Option to Extend the Contract

The Contractor grants to Canada the irrevocable option to acquire the goods, services or both described at Appendix 1 to Annex B of the Contract under the same conditions and at the prices and/or rates stated in the Contract. The option may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

The Contracting Authority may exercise the option within 12 to 60 months after contract award by sending a written notice to the Contractor.

6.5 Task Authorization

The Work or a portion of the Work to be performed under the Contract will be on an "as and when requested basis" using a Task Authorization (TA). The Work described in the TA must be in accordance with the scope of the Contract.

3. The Contractor must provide the Contracting Authority, within 5 calendar days of its receipt, the proposed total estimated cost for performing the task and a breakdown of that cost, established in accordance with the Basis of Payment specified in the Contract.
4. The Contractor must not commence work until the TA authorized by the Contracting Authority has been received by the Contractor. The Contractor acknowledges that any work performed before a TA has been received will be done at the Contractor's own risk.
5. Verify that the articles received correspond with the packing slip that accompanies the shipment. Items incorrectly received are to be segregated pending receipt of disposition instructions;
6. Carry out a physical check to ensure that the item is complete and is in accordance with the accompanying delivery documents;
7. Verify receipt to the Contracting Authority including any losses or discrepancies in the shipment and receipt of incorrect items;
8. Open a work order;
9. Action any warranty activities;

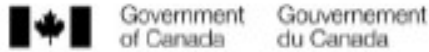

ANNEX B STATEMENT OF WORK FOR THE CASUALTY BIOLOGICAL CHAMBER

1. SCOPE

1.1 Purpose

The purpose of this Statement of Work (SOW) is to describe the requirements for the provision of Casualty Biological Chambers (CBCs) to the Department of National Defence (DND).

1.2 Background

DND personnel may need to conduct operations in areas where biological hazards exist. In doing so, personnel are at risk of being contaminated and will thus require medical interventions outside of the Area of Operations. To safely transport a biologically contaminated casualty, special containment systems are required in order to prevent the spread of the hazard to personnel and equipment. The CBC systems will allow for the transportation of the patient, ongoing medical interventions to be performed during the encapsulation, management of the air supply to the casualty through negative pressure and the containment of any liquid waste from the casualty.

1.3 Applicable Documents

The following documents form part of this SOW to the extent specified herein, and are supportive of this SOW when referenced; any other documents are to be considered supplemental information only. In the event of a conflict between the documents referenced and the contents of this SOW, the contents of this SOW must take precedence.

1.4 Definitions

Maintenance	All actions taken to keep materiel in, or to restore it to, specified conditions. It includes: recovery, inspection, testing, servicing, as to serviceability, repair, modification, rebuilding and reclamation.
OEM Level Repair	Any tasks required to bring an item to full serviceable condition, which can only be performed by the OEM. OEM repair will typically involve replacement/repair of internal components.
Overhaul	The restoration of an item to its original condition and near to its original life expectancy. It includes the replacement of worn, damaged or life expired parts, the incorporation of approved modifications and the rework of components as necessary. The depth of work will normally be to manufacturer's standards using replacement parts produced by the original equipment manufacturer or equivalent quality.
Repair	That corrective maintenance activity which restores an item to serviceable condition by correcting faults or replacing unserviceable pieces of the item with new, overhauled, rebuilt or reconditioned components.
Repair and Overhaul	The act of returning an item to a serviceable condition by disassembly, repair or replacement of damaged or deteriorated parts, reassembly, adjustment, examination and testing to specified standards. Whereas repair normally entails the correction of specific defects only, overhaul entails not only the replacement of worn and damaged parts but also of parts whose service life has expired or is

	about to expire, in order to return the item to its original performance and an acceptable life expectancy.
Serviceable Condition	The condition classification assigned to an item, which can be used without restriction for its intended purpose.
Technical Support	User assistance via phone, e-mail or live-chat for individuals having technical problems with a given product, especially with respect to electronics or software. The technical support team is made up of specialists who are familiar with the ins and outs of the product and are able to troubleshoot most problems that a user experiences.
Turn Around Time	The time from when a non-serviceable item arrives at the Contractor repair facility to when the repaired item departs the repair facility.

2.1 Contract Kick-Off Meeting

The Contractor must host a contract kickoff meeting at its production facility or by teleconference, as arranged with the Technical Authority (TA), within four weeks of contract award. This meeting will be used to introduce the DND project team and to discuss delivery timelines, Quality Assurance (QA) processes, and contract deliverables. DND will be responsible for all travel and associated costs for DND personnel attending the meeting. The agenda will be jointly developed by DND and the Contractor. The contractor will produce meeting minutes and an action item list, within five days of completion of the meeting.

2.2 Technical Data Package

The Contractor must provide a TDP as follows:

- a. One hard copy and one electronic copy (MS Word or PDF format) of the Operators Manual in both English and French languages, that includes illustrated set-up, operating, preventive and user maintenance, including procedures to replace all consumables, troubleshooting and safety instructions;
- b. One hard copy and one electronic copy (MS Word or PDF format) of the Maintenance/Repair Manual in both English and French languages, with each device that includes a list of replaceable components (including part numbers where applicable) and the procedures, parts and special tools necessary to conduct repairs;

Note: The operator and maintenance manuals may be delivered as one manual.

- c. An equipment checklist in both English and French languages, in accordance with the following:
 - (1) The equipment checklist must be a weatherproof concise guide, such as a laminated single card or small laminated folded sheet;

- (2) Quantity one equipment checklist must be included with each operational kit, and an electronic copy must be provided to the TA as well;
 - (3) The equipment checklist must use color pictorials or drawings to identify item location in the operational kit;
 - (4) The equipment checklist must list the contents of the system and map the system component connectivity when unpacked, and show their system component layout when fully packed for transport; and
 - (5) Data to be included are:
 - (a) Item number;
 - (b) Item name;
 - (c) Part number; and
 - (d) Quantity.
- d. An Illustrated Parts List (IPL) in a top-down breakdown format with the following information for each item both English and French languages :
- (1) Level II engineering drawing and/or applicable lists in accordance with D-01-100-214/SF-000;
 - (2) Item name and Descriptions;
 - (3) NCAGE;
 - (4) Manufacturer's Part Number (MPN) and corresponding Distributors Part Numbers (if applicable);
 - (5) NATO Stock Number (NSN) if available; and
 - (6) Shelf life (if applicable).
- e. One electronic copy of available supporting test reports and/or compliance certificates upon request; and
- f. A list of the serial numbers (if available) for each of the units to be delivered.

2.3 Training

The Contractor must provide training, in English, as follows:

- a. An outline for the Training Course (MS Word, MS PowerPoint or PDF format) must be submitted to the TA for approval within 30 days of contract award;
- b. A two-day, 16 hour maximum, Train-the-Trainer Maintenance/Operator course as follows:
 - (1) Training serial at DND's facility in Trenton, Ontario;
 - (2) Training for up to 20 DND candidates per serial;

- (3) For each course, each candidate is to be provided with a copy of the respective system training courses and manuals (as required) in both hard copy and in electronic format (MS Word, MS PowerPoint or PDF); and
- (4) The course content must include the following details as a minimum:
 - (a) Complete description of theory of operation and performance capability of the system;
 - (b) Hands-on familiarization to include:
 - i. Assembly and setup of the system;
 - ii. General usage procedures for patient care and transport;
 - iii. Battery/power requirements;
 - iv. Function buttons;
 - v. Modes of operation;
 - vi. User trouble shooting;
 - vii. Daily/routine operator maintenance;
 - viii. Repair and testing techniques for the system;
 - ix. Calibration methods of the system; and
 - x. Consumables' estimated life and replacement procedure.
 - (c) Care and cleaning requirements of the system, inclusive of approved cleaning products and methods; and
 - (d) Technical diagnosis of the system to include fault-finding procedures or decision flow chart.

3. REQUIREMENTS

3.1 Configuration Management (CM)

The Contractor must have an established, DND verifiable, Configuration Management (CM) Program which complies with or meets the intent of MIL-HDBK-61B, and must provide configuration identification, control and status accounting of all new and/or modified hardware, firmware, software and documentation. All CBC components delivered must have the same product baseline, and support interchangeability/interoperability of parts. The established product baseline must be maintained during repair and any deviation from the baseline must be approved by the TA before the repair is initiated.

3.2 Product Support

The Contractor must provide product support for the CBC operational kits throughout the duration of the contract as follows:

- a. Additional Work Request (AWR) services in accordance with Section 3.2.22.2, including:
 - (1) Non-warranty repair;

- (2) OEM Planned Maintenance;
- (3) Hardware modifications; and
- (4) The provision of a Field Service Representative (FSR) to conduct on-site engineering and/or maintenance support at a DND facility or location.

b. Technical Support in accordance with section 3.2.4.

3.2.1 Turn-Around Time

For all repairs, the targeted turn-around time (TAT) is 30 calendar days after receipt of a request from DND; including warranty and AWR repair. Where this target cannot be met, the Contractor must promptly notify the PA of the delay and of any extenuating circumstances that would cause significant impediment to timely completion of the repair.

3.2.2 Additional Work Request

The Contractor must provide non-warranty Additional Work Request (AWR) services on an as-and-when requested basis. All AWR repairs on CBC units are to be authorized in advance by the CA (in writing) in accordance with the repair procedure detailed in 6.5.1 Task Authorization Process.

3.2.2.1 Repair to Product Baseline

Following repair, the Contractor must ensure all CBC components are in accordance with the respective approved Product Baseline prior to being returned to DND. Following repair or maintenance, the Contractor must conduct functional/performance testing to ensure proper operation of the CBC components, and then ship the system to the delivery point specified in the delivery order, unless otherwise requested by the PA.

3.2.3 Contractor Supplied Parts

The Contractor must provide the repair parts required for warranty and AWR repairs, including the location of sources for the required parts. The Contractor is not required to maintain a spares inventory specifically for DND; however, they must maintain a spares supply chain sufficient to support DND's requirements and continued use of the CBC. In the event that an original part is no longer available and the Contractor determines that a replacement part will serve with respect to fit, form, function, interface and reasonable cost, then the use of that part must be approved by the TA in advance of the repair. As a minimum, when the product baseline and/or configuration changes the Contractor must provide DND the following information for replacement parts approved for use by the TA:

- a. Provide DND notification that the old and new parts are interchangeable;
- b. Assign the new unique MPN and vendor code; and
- c. Update all necessary CBC technical documentation and provide the updated data to DND.

3.2.4 Technical Support

The Contractor must provide technical support, during normal working hours, which are defined as 0800-1700 local time at the Contractor's facility. Technical support may be provided by telephone and/or internet website/application. When DND notifies the contractor of a technical issue an initial response acknowledging the request and a statement of next steps must be submitted by the Contractor within 24-hours.

This specification outlines the operational performance and technical requirements for the Casualty Biological Chamber (CBC).

1.2 Definitions

1.4 Applicable Documents

The following documents form part of this specification to the extent specified and are supportive of this specification when referenced. In the event of a conflict between the documents and the contents of this specification, then the contents of this specification must take precedence.

- American Society of Mechanical Engineers, ASME AG-1a-2004, "Addenda to ASME AG-1-2003 Code on Nuclear Air and Gas Treatment", 2004.

2.0 REQUIREMENTS

2.1 Operational Requirements

- a. The CBC must have a mass of 35kg or less, in operational configuration;
- b. The CBC should have a mass of 15kg or less, in operational configuration;
- c. The CBC chamber must meet the following dimensional constraints:
 - (1) Must accommodate a completely supine patient length of 1947 mm (corresponding to a 95-th percentile Canadian Armed Forces [CAF] male stature) in operational configuration;
 - (2) Must not exceed a maximum overall external chamber length of 2300mm in operational configuration;

- (3) Must accommodate a patient width of 576 mm (corresponding to a 95-th percentile CAF male bi-acromial breadth) in operational configuration;
 - (4) Must not exceed a maximum overall external chamber width of 750 mm; and
 - (5) Should not exceed dimensions of 650mm x 550mm x 600mm (length x width x height) when completely collapsed for transportation, without the filtration system.
- d. The CBC must provide full body view (i.e. head to toe visibility, and full 180° visibility, perpendicular to the long axis of the body) of the casualty;
 - e. The CBC must have an internal harness system to secure the casualty within the chamber against injury during transport;
 - f. The CBC must be able to be secured to the North American Rescue Talon II stretcher without additional hardware;
 - g. The CBC must be able to be secured to the Stryker Performance Pro XT gurney without additional hardware;
 - h. The CBC must maintain its operating form without active ventilation;
 - i. The CBC must permit easy lowering of the patient into the chamber by means of a completely opening top section;
 - j. The CBC must allow the containment of 10 litres of liquid waste within the chamber base without leakage, while the patient is lying completely supine and the CBC is fully open;
 - k. The CBC should provide a means of keeping the patient elevated above or otherwise separated from 20 litres of liquid waste within the chamber base, while the patient is lying completely supine;
 - l. The CBC should allow the containment of 20 litres of liquid waste within the chamber base without leakage, while the patient is lying completely supine and the CBC is fully open;
 - m. The CBC must be made of durable materials to withstand rough handling in austere conditions without compromising the protection performance of the CBC; and
 - n. The CBC should have no degradation of performance (with the exception of rechargeable batteries) when stored in the original packaging in a climate-controlled setting for a period of up to 5 years.

2.2 Technical Requirements

- a. Filtration:
 - (1) The CBC must use a powered negative pressure ventilation system (i.e., must not rely on human/casualty respiration for air exchange);
 - (2) The CBC must exchange air at a minimum of 12 Air Changes per Hour;

- (3) The CBC should exchange air at up to 50 Air Changes per Hour;
- (4) The negative pressure ventilation system must be physically separate from the containment chamber;
- (5) The CBC biological threat filtration system must filter the exhaust air from the CBC using filter(s) that without reducing the flow rate of the system, meets the HEPA standard in accordance with American Society of Mechanical Engineers, ASME AG-1a-2004, "Addenda to ASME AG-1-2003 Code on Nuclear Air and Gas Treatment", 2004, or an equivalent or more stringent standard to be proposed by the bidder and accepted by the Technical Authority (TA); and
- (6) The CBC biological threat filter(s) should have a useful life of at least 8 hours at 20 deg C without replacement of any filtration elements.

b. Medical Intervention:

- (1) The CBC must have a minimum of four (4) ambidextrous glove ports per side of the chamber, with two (2) providing access to the chest and two (2) providing access to the lower extremities;
- (2) The CBC should provide two (2) ambidextrous glove ports at the head end of the chamber;
- (3) Each of the CBC glove ports should provide a means to leave the port sealed when the glove is not in use;
- (4) The gloves, if permanently installed in the CBC chamber, should be secured to the side of the CBC until use;
- (5) The CBC must have a minimum of one (1) separate (from glove ports) utility port for exchange of medical supplies or lines;
- (6) The CBC should have three (3) separate (from glove ports) utility ports, one each at the casualty head, mid-torso and feet;
- (7) The utility port(s) must allow the passage of supplies into the CBC without breaking isolation; and
- (8) The CBC should provide storage compartments along the interior, accessible via the glove ports to enable pre-positioning of treatment supplies.

2.2.1 Power

The CBC:

- a. Must operate on a standard North American power input of 120 VAC at 60 Hz;
- b. Should operate on a power input of 100 – 240 VAC at 50/60 Hz;
- c. Should operate on a standard 12 V DC automobile power input;

- d. Must operate on an internal rechargeable battery or batteries;
- e. Must be powered for at least 4 hours, at 20 deg C, from the internal rechargeable battery or batteries, on a single charge (i.e., without charging or swapping batteries); and
- f. Should be powered for 8 hours or more, at 20 deg C, from the internal rechargeable battery or batteries, on a single charge (i.e., without charging or swapping batteries).

2.2.2 Transportation

The CBC:

- a. Must include a non-rigid carrying case, with sufficient room in it for the entire CBC operational kit (item 2.3 a. [including all subparagraphs], below);
- b. Must not have any PVC (Polyvinyl Chloride) insulation materials on wire and electrical components; and
- c. Must have a valid airworthiness certificate, or waiver, issued by Transport Canada or a similar agency, for use on commercial and/or military aircraft when powered from 120 VAC at 60 Hz or internal batteries.

2.3 Kit Configurations

The CBC kit configurations for the deliverables are as follows:

- a. CBC operational kit:
 - (1) Quantity one (1) containment chamber kit, which meets the requirements of item b. of this section (including all subparagraphs) below;
 - (2) Quantity one (1) ventilation system kit, which meets the requirements of item c. of this section (including all subparagraphs) below;
 - (3) Quantity one (1) biological threat ventilation kit, which meets the requirements of item d. of this section (including all subparagraphs) below;
 - (4) Quantity one (1) rechargeable batteries kit, which meets the requirements of item e. of this section (including all subparagraphs) below; and
- b. Containment chamber kit:
 - (1) Quantity one (1) casualty containment chamber, including gloves for each glove port, seals, ports or other attachable accessories, which meets the requirements of sections 2.1 and 2.2 b.;
 - (2) Quantity one (1) carrying case, which meets the requirements of section 2.2.2.;
 - (3) Quantity one (1) operator and maintenance manual, hard copy only, which meets the documentation requirements of Annex B; and

- (4) Any other hardware required for operation of the CBC and/or to meet requirements of sections 2.1 and 2.2, which are not described in sections c, d, or e, below.

c. Ventilation system kit:

- (1) Quantity one (1) complete ventilation system, including all applicable hoses, lines, vents, connectors and accessories for attaching to the containment chamber, which meets the requirements of sections 2.2 a. (1), (2), (3) and (4), and 2.2.1.

d. Biological threat filtration kit:

- (1) Quantity one (1) complete biological filter kits, with the filters and any other associated consumable items to provide 8 hours of continuous operation of the CBC at 20 deg C, which meet the requirements of sections 2.2 a. (5) and (6).

e. Rechargeable batteries kit:

- (1) Quantity one (1) set of sufficient batteries to provide 8 hours of continuous operation of the CBC at 20 deg C, which meet the requirements of section 2.2.1 d., e. and f.; and
- (2) Quantity one (1) set of charging devices sufficient to charge all batteries in the kit at the same time.
