Question #50:

Please confirm that an upgrade is moving from one version to another (either like for like and/or additional functionality) and an implementation of a new system or on-boarding to a shared platform would not qualify.

Answer #50:

A PeopleSoft upgrade is moving from one version to a newer version.

An upgrade can be done:

- In-place, installing the new version in top of the old version, or
- As a new installation, where the deployment of the new version is done in a new instance and then the data, configurations and customizations are migrated from the old system to the new system.

As a result, an implementation of a new PeopleSoft system from ground up with the data migrated to it from another source is considered an upgrade.

However, the on-boarding activity alone does not qualify as an upgrade.
