Description of Work:

As part of its planning for possible future activities and collaboration with different stakeholders, the Canadian space Agency is requesting the services of experienced business consultant (resource or team) to perform a socio-economic study on the benefits of measuring green-house gases, air quality and providing meteorological services in the North.

The scope is to quantify and qualify the potential socio-economic benefits to Canadians of satellite-derived information on meteorological, greenhouse gas and air quality measurements over Canada's northern regions. This will be done by using a 'value of information' framework and other relevant methodologies such as cost-avoidance analysis, while employing a Gender-Based Analysis + (GBA+) lens, all based on international best practices in order to assess the impact a potential Arctic Observing Mission could have for Canada.
