### **DRAWING REVISIONS**

The document titled, '5000063759 Annex B - Amendment 1 - Drawings\_Dessins - 1 - River Cableway Drawings - General Final,' is provided to clarify some drawing references made in some of the drawing sheets. The wordings that make references to the D504 Drawing are removed to avoid any further confusion. The D504 Drawing is not applicable to the project and it does not exist.

In addition, the document titled, '5000063759 Annex B – Amendment 1 - Drawings\_Dessins – SUPPLEMENTARY Drawings to -1 – River Cableway Drawings - General Final,' is provided to further outline the new cableway. Please disregard the D504 Drawing references, as noted above.
