- Q1. What is meant by Corporate Services in question 2.3.2 of the Technical Evaluation Criteria?
- R1. The corporate services mentioned in question 2.3.2 of the Technical Evaluation Criteria are the services and associated tasks and activities performed to support and effectively enable the delivery of the property, maintenance, minor project delivery and optional services referenced in the Statement of Work. Thus defined, corporate services would include functions such as financial management and accounting, procurement, human resource management and information technology development and management, among others.
- Q2. APPENDIX E, ATTACHMENT 1 to Part 3 of the BID SOLICITATION requests that we provide our cost in pound sterling (£), however the figures used for the Operational Baseline for Evaluation have been provided in Canadian Dollars (\$). Please confirm if this is correct.
