The purpose of this amendment is to answer industry questions.

ANSWERS TO INDUSTRY QUESTIONS

Enquiries - Bid Solicitation

To ensure consistency and quality of information provided to bidders, significant enquiries received and the replies to such enquiries will be provided simultaneously to bidders to which the bid solicitation has been sent, without revealing the sources of the enquiries.

Here are the questions which we have received:

Question 1	Regarding the definition of "Arctic" region, does Canada consider the latitudes of all North Warning System radar sites to be in the Arctic region? Alternatively, per the definition provided for 'northern region' in Solicitation W6369-180007-04 (Ellesmere Island Commercial Support: DND Site Services at Canadian Forces Station Alert), may "Arctic region" refer to areas "primarily north of the 60th parallel and at isolated areas that are subject to colder winter conditions, heavy snowfalls and short summers"?
Answer 1	<p>The North Warning System spans latitudes that are below and above of the 60th parallel; all of which are isolated and subject to colder winter conditions, heavy snowfalls and short summers and thus can be considered to fall broadly under the Arctic Region.</p> <p>Therefore, for the purposes of this solicitation "Arctic Region" refers to : Regions that are isolated and subject to colder winter conditions, heavy snowfalls and short summers.</p>
