1. To answer questions from Vendors during the Solicitation period.

Question 12.

We have noticed that on Annex E Appendix 1 Technical Evaluation Workbook for Phase 1 for solicitation W8476-216392/C – Pistol & Holster, there is an error in the formatting on the spreadsheet. When entering the 'Bidder's Compliance Self Assessment' in Column 5, the following Sections are not being counted in the 'Number of Compliant Mandatory Requirements' cell:

3.24.1
3.24.1.1
3.24.2
3.24.2.1

How does Canada wish us to proceed with our submission considering it may appear the submission is not meeting full compliance?

Answer 12.

The formula in cell G10 counts the number of cells in Column 5 (cell range E19 to E153) where the bidder has self assessed their bid as "Compliant". The formula range should have been from cells E19 to E157 to capture the four new technical requirements added in solicitation W8476-216392/C. As a result the formula is not counting the last 4 technical requirement. Canada will amend the formula so that it calculated properly on receipt of the bidders electronic copy of Appendix 1 to Annex E.
