SOLICITATION AMENDMENT 005

This Solicitation Amendment is issued to answers questions from Industry.

SECTION A - QUESTIONS AND ANSWERS

Question 15

Would DND accept nylon webbing in Camouflage pattern for the pre-award sample, as a substitute material?

Answer 15

DND is willing to allow a deviation at the pre-award sample submission for the colour of the webbing in accordance with Annex B, paragraph 3.3.5. Bidders must submit a covering letter stating that, if awarded a contract for the Hat, Sun, Temperate Weather, Combat CADPAT™ TW (NSN 8515-21-914-5176 A/A), the webbing will be fully compliant with the requirements outlined in Annex B.

Question 16

Would DND accept the use of a label from a previous Sun Hat contract, for the pre-award sample, as a substitute material?

Answer 16

The label must be in accordance with Annex B, paragraph 3.3.10 and paragraph 3.7. Additional information is in specification D-80-001-055/SF001. A label from a previous Sun Hat contract cannot be used. For the pre-award sample, the Contract number is the Solicitation number. Please refer to Change 5 below.

Question 17

In regards to the bar tacks mentioned in the Annex B, paragraph 3.6.7.6, can DND specify whether we need to place seven bar tacks to secure the sweatband or not, since webbing is only applied to accommodate the reversible cat's eyes? If yes, what are their positions? If not, how should we attach or secure the sweatband?

Answer 17

According to the Annex B, paragraph 3.6.7.6, to secure the sweatband, single bar tacks must be placed evenly for a total of seven bar tacks around the sweatband. The stitching must be done through all layers of the hatband and sweatband. Care must be taken to ensure that the sweatband is in the appropriate position while stitching through all layers. In order to correctly place the bar tacks to secure the sweatband, please refer to the sealed sample DSSPM 109-99.

Question 18

Regarding the webbing specified in Annex B, paragraph 3.3.5, can DND clarify whether the webbing must be Canadian Average Green or Printed Camouflage Canadian Average Green?

Question 19

Can we use substitute trims on our sample and submit the official trim with its accompanying CoC?

Answer 19

DND is willing to allow for deviations at the pre-award sample submission for the colour of the trims, as long as the trims are in accordance with their respective specification in Annex B. Bidders must submit a covering letter stating that, if awarded a contract for the Hat, Sun, Temperate Weather, Combat CADPAT™ TW (NSN 8515-21-914-5176 A/A), the trim that was substituted will be fully compliant with the requirements outlined in Annex B

Question 20

Would DND accept nylon webbing in Canadian Average Green solid colour without Temperate Woodland pattern? If not, can DND extend the closing date to accommodate getting a sample made?

Question 21

Regarding the toggle specified in Annex B, paragraph 3.3.7, the requirement is for a non-metallic tension adjustment mechanism. Can we use a metallic tension adjust mechanism with rust proof?

Answer 21

There will be no changes to the toggle requirements identified in Annex B, paragraph 3.3.7.

SECTION B - CHANGES TO THE BID SOLICITATION

Change 4

At Annex B, Para 3.3.5,

DELETE in its entirety and INSERT:

3.3.5 Webbing.

The webbing must be spun polyester, double jacquard weave, 19 g/m (+/- 5%) in weight, the warp ends must be 192 warp yarns per centimetre with 19 weft yarns per centimetre. Thickness must be 1.7mm (+/- 10%) and the width must be 9/16-inch (14.3 mm). The colour must be Canadian Average Green.

Change 5

At Annex B, Para 3.7,

DELETE in its entirety and INSERT:

- 3.7 **Marking and Label Information**. The following marking and care symbols must be printed legibly and indelibly with black printing on a coloured label (Canadian Average Green) and in accordance with specification D-80-001-055/SF-001, Type I. The fabric must be nylon, acetate, or polyester. The label must be nominally 2-inches (5.0 cm) long by 1-1/4 inches (3.2 cm) wide. See Figure 4 for placement of the label (marked identification label on figure).
 - a. NATO Stock Number (NSN) that is specific for each size. NSN's will be

designated in the contract by item and size;

- b. Size (twice the size of all other lettering);
- c. Contractor's identification or CA number;
- d. Contract Number;
- e. Month and year of manufacture (MM/YYYY);
- f. Space to write personal identification;
- g. Care Symbols in accordance with CAN/CGSB-86.1-2003 as follows:

Washing Symbol 6;
 Bleaching Symbol 3;
 Drying Symbol 2; and
 Ironing/Pressing Symbol 5
