## GENERAL INSTRUCTIONS TO OFFERORS – CONSTRUCTION SERVICES (GI)

### GI01 (2016-04-04) Integrity provisions—Offer

1. The *Ineligibility and Suspension Policy* (the “Policy”) in effect on the date the offer solicitation is issued, and all related Directives in effect on that date, are incorporated by reference into, and form a binding part of the offer solicitation. The Offeror must comply with the Policy and Directives, which can be found at [Ineligibility and Suspension Policy](#).
2. Under the Policy, charges and convictions of certain offences against a Offeror, its affiliates or first tier subcontractors, and other circumstances, will or may result in a determination by Public Works and Government Services Canada (PWGSC) that the Offeror is ineligible to enter, or is suspended from entering into a contract with Canada. The list of ineligible and suspended Suppliers is contained in PWGSC’s Integrity Database. The Policy describes how enquiries can be made regarding the ineligibility or suspension of Suppliers.
3. In addition to all other information required in the offer solicitation, the Offeror must provide the following:
  - a. by the time stated in the Policy, all information required by the Policy described under the heading “Information to be Provided when Offering, Contracting or Entering into a Real Property Agreement”; and
  - b. with its offer, a complete list of all foreign criminal charges and convictions pertaining to itself, its affiliates and its proposed first tier subcontractors that, to the best of its knowledge and belief, may be similar to one of the listed offences in the Policy. The list of foreign criminal charges and convictions must be submitted using an Integrity Declaration Form, which can be found at [Declaration form for procurement](#).
4. Subject to subsection 5, by submitting an offer in response to this offer solicitation, the Offeror certifies that:
  - a. it has read and understands the [Ineligibility and Suspension Policy](#);
  - b. it understands that certain domestic and foreign criminal charges and convictions, and other circumstances, as described in the Policy, will or may result in a determination of ineligibility or suspension under the Policy;
  - c. it is aware that Canada may request additional information, certifications, and validations from the Offeror or a third party for purposes of making a determination of ineligibility or suspension;
  - d. it has provided with its offer a complete list of all foreign criminal charges and convictions pertaining to itself, its affiliates and its proposed first tier subcontractors that, to the best of its knowledge and belief, may be similar to one of the listed offences in the Policy;
  - e. none of the domestic criminal offences, and other circumstances, described in the Policy that will or may result in a determination of ineligibility or suspension, apply to it, its affiliates and its proposed first tier subcontractors; and
  - f. it is not aware of a determination of ineligibility or suspension issued by PWGSC that applies to it.
5. Where an Offeror is unable to provide any of the certifications required by subsection 4, it must submit with its offer a completed Integrity Declaration Form, which can be found at [Declaration form for procurement](#).
6. Canada will declare non-responsive any offer in respect of which the information requested is incomplete or inaccurate, or in respect of which the information contained in a certification or declaration is found by Canada to be false or misleading in any respect. If Canada establishes after award of the Contract that the Offeror provided a false or misleading certification or declaration, Canada may terminate the Contract for default. Pursuant to the Policy, Canada may also determine the Offeror to be ineligible for award of a contract for providing a false or misleading certification or declaration.

### GI02 (2014-03-01) Completion of offer

1. The offer shall be
  - a. submitted on the Offer and Acceptance Form provided through the Government Electronic Tendering Service (GETS) or on a clear and legible reproduced copy of such Offer and Acceptance Form that must be identical in content and format to the Offer and Acceptance Form provided through GETS;
  - b. based on the Offer Documents listed in the Special Instructions to Offerors;
  - c. correctly completed in all respects;

- d. signed by a duly authorized representative of the Offeror; and
  - e. accompanied by
    - i. any other document or documents specified elsewhere in the solicitation where it is stipulated that said documents are to accompany the offer.
2. Subject to paragraph 6) of GI11, any alteration to the pre-printed or pre-typed sections of the Offer and Acceptance Form, or any condition or qualification placed upon the offer may be cause for disqualification. Alterations, corrections, changes or erasures made to statements or figures entered on the Offer and Acceptance Form by the Offeror shall be initialed by the person or persons signing the offer. Alterations, corrections, changes or erasures that are not initialed shall be deemed void and without effect.
3. Unless otherwise noted elsewhere in the Offer Documents, facsimile copies of offers are not acceptable.
4. Canada will make available Notices of Proposed Procurement (NPP), offer solicitations and related documents for download through the Government Electronic Tendering Service (GETS). Canada is not responsible and will not assume any liabilities whatsoever for the information found on websites of third parties. In the event an NPP, offer solicitation or related documentation would be amended, Canada will not be sending notifications. Canada will post all amendments, including significant enquiries received and their replies, using GETS. It is the sole responsibility of the Offeror to regularly consult GETS for the most up-to-date information. Canada will not be liable for any oversight on the Offeror's part nor for notification services offered by a third party.

#### **GI03 (2015-02-25) Identity or legal capacity of the Offeror**

In order to confirm the authority of the person or persons signing the offer or to establish the legal capacity under which the Offeror proposes to enter into Contract, any Offeror who carries on business in other than its own personal name shall, if requested by Canada, provide satisfactory proof of

- a. such signing authority; and
- b. the legal capacity under which it carries on business;

prior to contract award. Proof of signing authority may be in the form of a certified copy of a resolution naming the signatory(ies) that is (are) authorized to sign this offer on behalf of the corporation or partnership. Proof of legal capacity may be in the form of a copy of the articles of incorporation or the registration of the business name of a sole proprietor or partnership.

#### **GI04 (2015-02-25) Applicable Taxes**

"Applicable Taxes" means the Goods and Services Tax (GST), the Harmonized Sales Tax (HST), and any provincial tax, by law, payable by Canada such as, the Quebec Sales Tax (QST) as of April 1, 2013.

#### **GI05 Listing of Subcontractors/Supplier**

(Applicable on call-ups)

The Offeror must submit the names of Subcontractors/Supplier for the part or parts of the Work listed. See ANNEX D.

#### **GI06 (2014-03-01) Submission of offer**

- 1. Canada requires that each offer, at solicitation closing date and time or upon request from the Contracting Authority, be signed by the Offeror or by an authorized representative of the Offeror.
- 2. It is the Offeror's responsibility to:
  - a. submit an offer, duly completed, in the format requested, on or before the solicitation closing date and time set;
  - b. In the case of submission by CPC Connect, see instructions in GI06.2.f below.

- c. obtain clarification of the requirements contained in the RFSO, if necessary, before submitting an offer;
- d. ensure that the Offeror's name, return address, the solicitation number and description, and solicitation closing date and time are clearly visible on the submission containing the Offer; and
- e. provide a comprehensive and sufficiently detailed Offer that will permit a complete evaluation in accordance with the criteria set out in this RFSO.
- f. send its Offer only to the Bid Receiving Unit of Public Works and Government Services Canada (PWGSC) specified below, by the date and time indicated on page 1 of the offer solicitation, by electronic CPC Connect submission as follows:

- a. Unless specified otherwise in the solicitation, offers may be submitted by using the [CPC Connect service](#) provided by Canada Post Corporation.
- b. The only acceptable email address to use with CPC Connect for responses to solicitation issued by PWGSC is:

**Note:** Offers will not be accepted if emailed directly to this email address. This email address is to be used to open an CPC Connect conversation, as detailed in c., or to send offers through an CPC Connect message if the Offeror is using its own licensing agreement for CPC Connect.

- c. To submit an offer using CPC Connect service, the Offeror must either:
  - i. send directly its offer only to the specified PWGSC Bid Receiving Unit, using its own licensing agreement for CPC Connect provided by Canada Post Corporation; or
  - ii. send as early as possible, and in any case, at least six business days prior to the solicitation closing date and time, (in order to ensure a response), an email that includes the offer solicitation number to the specified PWGSC Bid Receiving Unit requesting to open an CPC Connect conversation. Requests to open an CPC Connect conversation received after that time may not be answered.
- d. If the Offeror sends an email requesting CPC Connect service to the specified Bid Receiving Unit in the solicitation, an officer of the Bid Receiving Unit will then initiate an CPC Connect conversation. The CPC Connect conversation will create an email notification from Canada Post Corporation prompting the Offeror order to access and action the message within the conversation. The Offeror will then be able to transmit its offer afterward at any time prior to the solicitation closing date and time.
- e. If the Offeror is using its own licensing agreement to send its offer, the Offeror must keep the CPC Connect conversation open until at least thirty (30) business days after the solicitation closing date and time.
- f. The solicitation number should be identified in the CPC Connect message field of all electronic transfers.
- g. It should be noted that the use of CPC Connect service requires a Canadian mailing address. Should an Offeror not have a Canadian mailing address, they may use the Bid Receiving Unit address specified in the solicitation in order to register for the CPC Connect service.
- h. For offers transmitted by CPC Connect service, Canada will not be responsible for any failure attributable to the transmission or receipt of the offer including, but not limited to, the following:
  - i. receipt of a garbled, corrupted or incomplete offer;
  - ii. availability or condition of the CPC Connect service;

- 
- iii. incompatibility between the sending and receiving equipment;
  - iv. delay in transmission or receipt of the offer;
  - v. failure of the Offeror to properly identify the offer;
  - vi. illegibility of the offer;
  - vii. security of offer data; or,
  - viii. inability to create an electronic conversation through the CPC Connect service.
- i. The Bid Receiving Unit will send an acknowledgement of the receipt of offer document(s) via the CPC Connect conversation, regardless of whether the conversation was initiated by the Offeror using its own license or the Bid Receiving Unit. This acknowledgement will confirm only the receipt of offer document(s) and will not confirm if the attachments may be opened nor if the content is readable.
  - j. Offerors must ensure that they are using the correct email address for the Bid Receiving Unit when initiating a conversation in CPC Connect or communicating with the Bid Receiving Unit and should not rely on the accuracy of copying and pasting the email address into the CPC Connect system.
  - k. A offer transmitted by CPC Connect service constitutes the formal offer of the Offeror.
3. The technical and price components of the offer must be submitted in separate sections as follows:
- a. The offer should be submitted following a "two-section" procedure of which is to include a technical and financial offer.
  - b. The Technical Offer, and any associated document(s), should be provided in a separate section with the following information clearly provided:
    - Section One - Technical Offer;
    - Solicitation Number; and
    - Name of Offeror.
  - c. The Price Proposal Form and associated document(s), the Financial Offer, should be provided in a separate section with the following information clearly provided:
    - Section Two - Financial Offer;
    - Solicitation Number; and
    - Name of Offeror.
4. Timely and correct delivery of offers to the office designated for receipt of offers is the sole responsibility of the Offeror. PWGSC will not assume or have transferred to it those responsibilities. All risks and consequences of incorrect delivery of offers are the responsibility of the Offeror.
5. Offers and supporting information may be submitted in either English or French.
6. Unless otherwise specified in the Special Instructions to Offerors:
- a. the offer shall be in Canadian currency; and
  - b. the requirement does not offer exchange rate fluctuation risk mitigation. Requests for exchange rate fluctuation risk mitigation will not be considered. All offers including such provision will render the offer non-responsive.

#### **GI07 (2010-01-11) Revision of offer**

- 1. An offer submitted in accordance with these instructions may be revised by [CPC Connect](#) provided the revision is received at the office designated for the receipt of offers, on or before the date and time set for the closing of the solicitation. The revision shall be on the Offeror's letterhead or bear a signature that identifies the Offeror.

2. A revision to an offer that includes unit prices must clearly identify the change(s) in the unit price(s) and the specific item(s) to which each change applies.
3. A revision submitted to confirm an earlier revision should be clearly identified as a confirmation.
4. Failure to comply with any of the above provisions may result in the rejection of the non-compliant revision(s) only. The offer shall be evaluated based on the original offer submitted and all other compliant revision(s).

#### **GI08 (2014-09-25) Rejection of offer**

1. Canada may accept any offer, whether it is the lowest or not, or may reject any or all offers.
2. Without limiting the generality of paragraph 1) of GI11, Canada may reject an offer if any of the following circumstances is present:
  - a. the Offeror's offering privileges are suspended or are in the process of being suspended;
  - b. the offering privileges of any employee or subcontractor included as part of the offer are suspended or are in the process of being suspended, which suspension or pending suspension would render that employee or subcontractor ineligible to offer on the Work, or the portion of the Work the employee or subcontractor is to perform;
  - c. the Offeror is bankrupt, or where for whatever reason, its activities are rendered inoperable for an extended period;
  - d. evidence, satisfactory to Canada, of fraud, bribery, fraudulent misrepresentation or failure to comply with any law protecting individuals against any manner of discrimination, has been received with respect to the Offeror, any of its employees or any subcontractor included as part of its offer;
  - e. evidence satisfactory to Canada that based on past conduct or behavior, the Offeror, a sub-contractor or a person who is to perform the Work is unsuitable or has conducted himself/herself improperly;
  - f. with respect to current or prior transactions with Canada
    - i. Canada has exercised, or intends to exercise, the contractual remedy of taking the work out of the Offeror's hands with respect to a contract with the Offeror, any of its employees or any subcontractor included as part of its offer; or
    - ii. Canada determines that the Offeror's performance on other contracts is sufficiently poor to jeopardize the successful completion of the requirement being offer on.
3. In assessing the Offeror's performance on other contracts pursuant to subparagraph 2)(f)(ii) of GI11, Canada may consider, but not be limited to, such matters as:
  - a. the quality of workmanship in performing the Work;
  - b. the timeliness of completion of the Work;
  - c. the overall management of the Work and its effect on the level of effort demanded of the department and its representative; and
  - d. the completeness and effectiveness of the Offeror's safety program during the performance of the Work.
4. Without limiting the generality of paragraphs 1), 2) and 3) of GI11, Canada may reject any offer based on a unfavorable assessment of the:
  - a. adequacy of the offer price to permit the work to be carried out and, in the case of a offer providing prices per unit, whether each such price reasonably reflects the cost of performing the part of the work to which that price applies;
  - b. Offeror's ability to provide the necessary management structure, skilled personnel, experience and equipment to perform competently the work under the Contract; and
  - c. Offeror's performance on other contracts.
5. Where Canada intends to reject an offer pursuant to a provision of paragraphs 1), 2), 3) or 4) of GI11, other than subparagraph 2)(a) of GI11, the contracting Authority will inform the Offeror and provide the Offeror ten (10) days within which to make representations, before making a final decision on the offer rejection.

6. Canada may waive informalities and minor irregularities in offers received if Canada determines that the variation of the offer from the exact requirements set out in the Offer Documents can be corrected or waived without being prejudicial to other Offerors.

#### **GI09 (2015-02-25) Offer costs**

No payment will be made for costs incurred in the preparation and submission of an offer in response to the offer solicitation. Costs associated with preparing and submitting an offer, as well as any costs incurred by the Offeror associated with the evaluation of the offer, are the sole responsibility of the Offeror.

#### **GI10 (2020-05-28) Procurement Business Number**

1. Bidders are required to have a Procurement Business Number (PBN) before Contract award. Bidders may register for a PBN in the Supplier Registration Information system on Web site: <https://buyandsell.gc.ca/for-businesses/selling-to-the-government-of-canada/register-as-a-supplier>.

#### **GI11 (2013-04-25) Compliance with applicable laws**

1. By submission of an offer, the Offeror certifies that the Offeror has the legal capacity to enter into a contract and is in possession of all valid licenses, permits, registrations, certificates, declarations, filings, or other authorizations necessary to comply with all federal, provincial and municipal laws and regulations applicable to the submission of the offer and entry into any ensuing contract for the performance of the work.
2. For the purpose of validating the certification in paragraph 1) of GI14, a Offeror shall, if requested, provide a copy of every valid license, permit, registration, certificate, declaration, filing or other authorization listed in the request, and shall provide such documentation within the time limit(s) set out in the request.
3. Failure to comply with the requirements of paragraph 2) of GI14 shall result in disqualification of the offer.

#### **GI12 (2010-01-11) Performance evaluation**

1. Offerors shall take note that the performance of the Offeror during and upon completion of the work shall be evaluated by Canada. The evaluation shall be based on the quality of workmanship; timeliness of completion of the work; project management, contract management and management of health and safety. Should the Offeror's performance be considered unsatisfactory, the Offeror's offering privileges on future work may be suspended indefinitely.

### SC01 SECURITY CLEARANCE REQUIREMENTS, DOCUMENT SAFEGUARDING

## APPENDIX 3 - STATEMENT OF WORK

### General Construction SOA

#### 1. PURPOSE

The purpose of the General Construction Standing Offer Agreement (SOA) is for construction services that include but are not limited to, installations, alterations and repair work, as and when required, at a variety of sites including, but not limited to office buildings, warehouses, storage facilities, detachments, garages, and private residences throughout British Columbia for various federal government departments of Canada. The work will comprise of the supply of all labour, material, tools, equipment, transportation and supervision necessary to carry out repairs, alterations and additions.

The Statement of Work (SOW) has been developed to ensure that the Contractor has a clear understanding of the Standing Offer Agreement (SOA) work scope, procedures and services.

#### 2. BACKGROUND INFORMATION

Work under this SOA will be requested on behalf of various federal government departments of Canada.

The Work performed under this SOA will take place in various locations throughout the province of British Columbia (BC). For the purposes of this standing offer agreement, the province of British Columbia has been divided into three geographic zones. Work may be requested in any of the communities within the boundaries noted below.

##### Zone #1 - Southwestern British Columbia

Zone #1 boundaries: Areas of British Columbia South of latitude 52.00N and West of longitude 121.00W including Vancouver Island.

Examples of communities/areas included within Zone #1 (not all inclusive): Lower Mainland including Greater Vancouver area and the Fraser Valley. Fraser Canyon north to Cache Creek and 100 Mile House. Squamish, Whistler, Pemberton, Sunshine Coast north to Powell River, Vancouver Island, Gulf Islands.

##### Zone #2 - Southeastern British Columbia

The contractor will be required to perform work in both urban and remote communities.

A geographic map of the zones is inserted at Appendix F.

#### 3. GENERAL INFORMATION

Each project conducted under this agreement will commence with a terms of reference (TOR) from the departmental representative. The TOR will contain specific details sufficient for the contractor to create and respond with a proposal complete with cost breakdowns. Approved proposals will result in call-ups to action the work.

#### 4. CATEGORIES OF REQUIRED PERSONNEL

The Contractor shall be qualified/certified to provide the necessary professional services to the full extent in the province of BC for the Class of Labour listed under 6. Required Services. A copy of the certificate for the senior carpenter is to be provided.

Required personnel must be employees of the Contractor and have the following minimum years of relevant experience. This does not include time at school or time working in a different discipline.

The Project Coordinator/Manager and Carpenter must be an in-house employee who works in the Contractor's organization/company.

A maximum of two resource categories of required personnel may be fulfilled by one individual (i.e. Project Coordinator/Manager may also be the Carpenter.)

Carpenters are not to perform outside of their designation (i.e. electrical or other specific trades work) unless proof of tickets/certificate are provided.

## 5. THE PSPC GENERAL CONDITIONS (GC)

- The Statement of Work document (SOW) must be used in conjunction with the General Conditions (GC) document, as the two documents are complimentary.
- The SOW describes work-specific requirements, services and deliverables while the GC document outlines the term and conditions of the call-up, common to all projects.
- In the case of a conflict between the two documents, the requirements of the GC override the SOW Document.

## 6. REQUIRED SERVICES

### SUMMARY OF CONSTRUCTION AND REPAIR WORK

Contractor is to provide all labour, equipment and material to complete assigned Work.

The scope of work will vary from project to project, but may include any combination of the following services identified in this Statement of Work.

Services may include, but are not limited to, the following:

#### Exterior construction

- Roof repairs or replacement.
  - Siding installation or repairs.
  - Window installation or repairs.
- Grounds work (installation or maintenance)
- Concrete or Asphalt work (foundations, walkways, driveways and parking lots)
- Installation or repairs of fences and gates
- Painting
- Landscaping.

#### Interior construction

- Repairs or alterations to walls (i.e. repairs to gypsum board, painting, relocating or constructing new walls).
- Repairs or alterations to floors (i.e. repairs or installation of vinyl, laminate or carpeting).
- Cabinetry and finish carpentry work.
- Plumbing.
- Painting

- Repairs or installation of domestic water supply and drain lines including wells.
- Installation of plumbing fixtures and hot water tanks.

#### **Foundations**

- Inspection and/or repairs to concrete slabs and foundations.

#### **Heating Ventilating Air-conditioning systems (HVAC)**

- Installation, repair or maintenance on HVAC equipment.

#### **Electrical**

- General electrical installations or repairs.
- Maintenance, repairs, inspections (monthly/annually) and installation of Emergency Generators.
- Maintenance, repairs and installation of Uninterruptable Power Supplies (UPS).

#### **Other tasks:**

- Assess potential construction works and provide recommendations options.
- Having the ability to outsource work to establish existing environmental hazards applicable to safely performing installations or remediation of assets.
- Prepare, review and submit for approval all required Shop Drawings.
- Preparation and submission of As-Built drawings to the Departmental Representative upon completion of the Work.
- Preparation and submission of maintenance manuals and standard operating procedures (SOP) to the Departmental Representative upon completion of the Work.

### **7. WORK EXPERIENCE**

A minimum of 2 years experience (within the last five (5) years) is required for all contractors or subcontractors' personnel with the exception of the Senior Carpenter, Project Coordinator/Manager and Apprentices/Trades Helpers. Canada reserves the right to verify the information through reference checks.

### **8. CERTIFICATION OF SUBCONTRACTORS**

The subcontractors shall be qualified/certified to provide the necessary professional services to the full extent in the province of BC for the Class of Labour listed under 6. Required Services. A copy of the valid certificates may be requested by the Departmental Representative.

### **9. CONSTRAINTS AND CHALLENGES**

1. The Contractor will be required to become familiar with the work site and obtain local information as required.
2. Construction services on the work site may or may not be performed during the full operation of the facilities. Work phasing must be planned to ensure that disruption to the daily operation of the facilities is kept to a minimum.
3. The Contractor must hold the required PSPC Security Clearance specified in the Standing Offer and comply with any additional requirements requested by each individual government department at the time of a call-up.

### **10. PROJECT DELIVERY APPROACH**

The contractor will submit proposals to the Departmental Representative (DR) based on the scope of work in the terms of reference (TOR). The proposals will be based on the firm hourly rates and mark-ups that have been identified in the Price Proposal.

To initiate the project the Departmental Representative (DR) will, when applicable, provide the following information:

- For complex projects, Plans and Specifications (if available) will be provided.
- In the case of less complex work the call-up scope or work may be described by sketch and/or narration.

Requirements for the Contractor during the project include but not limited to:

- The Contractor shall ensure full co-ordination of the work of all subcontractors.
- The Contractor is to prepare and submit to the Departmental Representative a detailed listing of all makes and models of equipment used to complete the scope of work.
- Work may be carried out during regular working hours.
- Work may be carried out after regular working hours, or on weekends.
- Work may be carried out when the site is occupied and operational.
- In the absence of a statement regarding hours of work or occupancy, it is assumed that the work will be carried out during regular working hours, when the facility is fully occupied and operational.
- Minimal disruption and interference with occupants, including the prevention of transmission of noise, when demolition or construction work occurs in the building or on the property.

#### 11. PRIME CONTRACTOR REQUIREMENTS

- The Contractor will be assigned the duties and responsibility of Prime Contractor (as defined by Work Safe BC regulations) when the contractor is the sole contractor on the call up work site.
- The Contractor may be assigned the duties and responsibility of Prime Contractor when sub-contractors occupy the same space and time.
- When the Contractor is acting in the capacity of the Prime Contractor, both construction and construction supervision for services are included within the assigned Work.

#### 12. SUB-CONTRACT

- Subcontracting is permitted under the terms of this SOA. The Contractor may subcontract the supply of goods or services. When the Contractor subcontracts work the Contractor is then acting as the Prime Contractor with all the inherent responsibilities and obligations.
- Subcontracting does not relieve the Prime Contractor from fulfilling any of its obligations under the terms of the SOA.
- In any subcontracts, the Contractor agrees to bind the subcontractor by the same conditions by which the Contractor is bound under the SOA.

#### 13. EXISTING DOCUMENTATION

##### DOCUMENTS AVAILABLE FOR THE SUCCESSFUL CONTRACTOR

- Copies of all work specific documentation will be made available to the Contractor at the time of the SOA Call-up.
- Operation & Maintenance Manuals and log books may be available on the work site. If referenced, the Contractor will be responsible for verifying the accuracy of the information contained and adding pertinent information upon completion of Standing Offer Agreement work.

#### 14. DISCLAIMER

1. Reference information will be available in the language in which it is written.
2. The documentation may be unreliable and is offered, "As is" for the information of the Contractor.

#### 15. CODES, ACTS, STANDARDS, REGULATIONS

The Work shall, unless otherwise specified, be constructed in a manner which is compliant with all applicable federal, provincial, municipal, and regional laws, acts, regulations, and Codes.

Adherence to all applicable codes and standards and without limiting the generality of the foregoing shall include the most current edition of the following:

- The NRC National Building Code of Canada,
- The NRC National Fire Code of Canada,

- The NRC National Plumbing Code of Canada,
- Canada Occupational Health and Safety Regulations,
- Canada Labour Code (including latest revisions of all regulations)
- The Canadian Electrical Code,
- C282 Emergency Electrical Power Supply for Buildings,
- B52 Refrigeration Code,
- National Fire Protection Association (NFPA) standards,
- American Society for Testing and Materials (ASTM),
- American Society of Heating, Refrigeration, and Air Conditioning Engineers, (ASHRAE)
- Worksafe, BC
- American National Standards Institute (ANSI),
- Local and/or municipal codes and bylaws.

In the event of a conflict between Codes, the most stringent shall take precedence.

## 16. PROJECT ADMINISTRATION

### GENERAL REQUIREMENTS

In response to a request for quotation and an accompanying TOR the contractor is responsible, at no cost to PSPC, to submit a proposal in conjunction with the TOR that shall include but is not limited to:

- a) Description of the work being completed.
- b) The roles and responsibilities of key personnel (internal) or external sub-contractors.
- c) Appendix of detailed cost table of personnel, rates, and hours compliant with Price Proposal.
- d) Appendix of detailed disbursements with rationale and back up quotes compliant with Price Proposal.
- e) The approach must be cost-efficient and ensure that the stated objectives of the project must be achieved. Proposed cost must not be exceeded without an amendment approved by Canada.
- f) Proposed milestone schedule (including shop drawings submissions and approval timelines and any other deliverables) that is reasonable and able to be completed within the time set in the proposal.

Prior to commencing work, the Contractor must confirm the following:

- The Call-up has been issued to the Contractor.
- All related permits that adhere to the local community, municipality, approvals, and agreements to a specific project are in place.
- DR approval on work schedule and DR and client approval for building access if required.
- All Health and Safety and Environmental Protection requirements are in place.
- Its understanding of the potential risks during the completion of the work.

Upon completion of work, the contractor is responsible for the following:

- Inform the Departmental Representative when work is completed, site inspection maybe required.
- Complete log books on site (e.g. HVAC, Electrical)

## 17. COMMUNICATIONS AND MEETINGS

If any communication with the Client Departments results in the need for any change to the scope of work, quality, cost or schedule, the Contractor shall inform the Departmental Representative (DR) and seek written direction. Only the DR can authorize scope of work changes; any unauthorized scope change will be at the cost of the Contractor.

There shall be no correspondence between occupants or users of the facilities and the Contractor, unless directed by the DR.

During the Work, the Contractor's Key Personnel shall be:

- Available to attend meetings and respond to inquiries within one (1) working day notice.
- Shall provide emergency contact information to be used in the event of any urgent project related event.

## **18. ROLES AND RESPONSIBILITIES**

### **CONTRACTOR**

The "Contractor's Team" must be eligible and registered to work in British Columbia.

The Contractor's team is composed of the Contractor and designated employees along with subcontractors and their designated employees as outlined in the SOA and SOA Call-up.

The Contractor and subcontractors must perform the work to a professional standard in the SOA and SOA Call-up.

The Contractor shall, during the construction phases, participate in construction meetings, ensure subcontractors attend required meetings and attend site inspection meetings.

The Contractor may be assigned the duties and responsibility of Prime Contractor when the contractor is the sole contractor on site and/or will oversee/monitor subcontractors. This may include review subcontractors documents for adherence.

The Contractor may be required to provide a full construction team as outlined in the SOA Call-up documents.

All those employed to work on the site are to meet the requirements of the provincially legislated Apprenticeship and Industry Training Act. Tradespersons are to be registered apprentice or certified journeyman, skilled, qualified and supervised.

## **19. THE PSPC TEAM**

- The PSPC Project Manager is the Departmental Representative and is responsible for conveying all Client Department requirements to the Contractor.
- The Departmental Representative will facilitate discussions between the main stakeholders of the overall project including, but not limited to; PSPC, the Consultant, the Contractor and Client Department stakeholders.

## **20. CLIENT DEPARTMENT RESPONSIBILITIES**

- The Client Department representative is responsible for communicating the interests of the federal government client department, in collaboration with the PSPC Departmental Representative.
- Unless directed otherwise, all communication with the Client Department is through the PSPC Departmental Representative.
- The Client Departmental Security Representative is responsible for the resolution of all security issues.

## **21. TEMPORARY STRUCTURES**

The contractor shall furnish and maintain all equipment such as scaffolding, ladders etc. as may be required for the proper execution of the work.

## **22. REMOVAL OF MATERIAL AND EQUIPMENT**

The contractor shall not remove any salvageable material and equipment from the job site without prior permission from the DR. This will be addressed on a project by project basis. The Client Department will determine if they wish to retain material or have it removed from the site. The DR will advise the Contractor.

The Contractor shall recycle materials wherever possible. The reuse of salvageable items is to be incorporated into pricing.

## **23. CLEAN UP**

On completion of the workday, remove all surplus material, plant tools, equipment and debris, and leave the job site in a clean, tidy and secure condition to the satisfaction DR.

Conduct cleaning and disposal operations to comply with local authorities:

- Do not bury rubbish and waste materials on project site
- Do not dispose of waste into streams or waterways
- Store volatile waste in covered metal containers and remove from premises daily
- Prevent accumulation of waste which create hazardous conditions. Do not conceal waste material in hidden spaces.

## 24. REPLACEMENT PERSONNEL

The replacement personnel must meet both qualifications and security requirements for the individual they are replacing. The Contractor must submit the qualifications of the proposed replacement. If the Qualifications are acceptable, they must then obtain Security clearance prior to commencing work. The Departmental Representative will evaluate each proposed replacement resource against the original bid evaluation criteria for these categories. In order to be approved, the resources must score equal to or greater than the scores that were given to the current resources in that category. Any replacement resources must have the prior authorization of the Departmental Representative before starting work.

The rates for the replacement personnel must be the same rate as the category their replacement was in or whichever category is appropriate based on their skills.

If the Contractor plans to move a pre-approved personnel listed in a certain category into another category, they must get pre-approval by PSPC and have qualifications and experience equal or better than the requirements of the new category.

## 25. SUMMARY OF HEALTH AND SAFETY

### Construction Safety and Maintenance Activities (deemed to be construction)

The following Construction and Maintenance Activities safety provisions are to be implemented for all construction projects under this Term of Reference.

#### a. GENERAL

##### PWGSC Update on Asbestos Use

Effective April 1, 2016, all Public Works and Government Services of Canada (PWGSC) contracts for new construction and major rehabilitation will prohibit use of asbestos-containing materials.

##### COVID 19

All contractors shall follow Canadian Construction Association COVID-19 - Standardized Protocols for All Canadian Construction Sites, Provincial Regulations and Federal Site Specific Guidelines.

## **27. WORKERS' COMPENSATION BOARD COVERAGE**

- Comply fully with the Workers' Compensation Act, regulations and orders made pursuant thereto, and any amendments up to the completion of the work.
- Maintain Workers' Compensation Board coverage during the term of the Call-up, until and including the date that the Certificate of Final Completion is issued.

## **28. COMPLIANCE WITH REGULATIONS**

- PSPC may terminate the Call-up without liability to PSPC where the Contractor, in the opinion of PSPC, refuses to comply with a requirement of the Workers' Compensation Act or the Occupational Health and Safety Regulations.
- It is the Contractor's responsibility to ensure that all workers are qualified, competent and certified to perform the work as required by the Workers' Compensation Act or the Occupational Health and Safety Regulations.

## **29. SUBMITTALS**

1. Submit to Departmental Representative any submittals listed for review.
2. Work affected by submittal shall not proceed until review is complete.
3. Submit the following:
  - Contractor's Site Specific Safety Plan or Health and Safety Plan (SSSP or HASP).
  - Copies of reports or directions issued by Federal and Provincial health and safety inspectors.
  - Copies of incident and accident reports.
  - Complete set of Material Safety Data Sheets (SDS), and all other documentation required by Workplace Hazardous Materials Information System (WHMIS) requirements.
  - Emergency Response Procedures.
4. The Departmental Representative will review the Contractor's Site Specific Safety Plan or Health and Safety Plan (SSSP/HASP) and emergency response procedures, and provide comments to the Contractor within 5 days after receipt of the plan. Revise the plan as appropriate and resubmit to Departmental Representative.
5. Medical surveillance: where prescribed by legislation, regulation or safety program, submit certification of medical surveillance for site personnel prior to commencement of work, and submit additional certifications for any new site personnel to Departmental Representative.
6. Submission of the Site Specific Safety Plan or Health and Safety Plan, and any revised version, to the Departmental Representative is for information and reference purposes only. It shall not:
  - Be construed to imply approval by the Departmental Representative.
  - Be interpreted as a warranty of being complete, accurate and legislatively compliant.
  - Relieve the Contractor of his legal obligations for the provision of health and safety on the project.

## **30. RESPONSIBILITY**

1. If one or more contractors are employed at the site, you may be requested to assume responsibility as the Principal Contractor for work under this contract and appoint a qualified coordinator for the purpose of ensuring the coordination of health and safety activities for the location in accordance with the Workers Compensation Act.
2. Be responsible for health and safety of persons on site, safety of property on site and for protection of persons adjacent to site and environment to extent that they may be affected by conduct of Work.
3. Comply with and enforce compliance by employees with safety requirements of Contract documents, applicable Federal, Provincial and local statutes, regulations, and ordinances, and with site-specific Health and Safety Plan.

### 31. HEALTH AND SAFETY COORDINATOR

Assign a competent and qualified Health and Safety Coordinator who shall:

- Be responsible for completing all health and safety training, and ensuring that personnel that do not successfully complete the required training are not permitted to enter the site to perform work.
- Be responsible for implementing, daily enforcing, and monitoring the Site Specific Safety Plan (SSSP) or Health and Safety Plan (HASP)
- Be on site during execution of work.
- Have minimum two (2) years' site-related working experience
- Have working knowledge of the applicable occupational safety and health regulations.

### 32. PROJECT/SITE CONDITIONS

- Provide safety barricades and lights around work site as required to provide a safe working environment for workers and protection for pedestrian and vehicular traffic.
- Ensure that non-authorized persons are not allowed to circulate in designated construction areas of the work site.
- Provide appropriate means by use of barricades, fences, warning signs, traffic control personnel, and temporary lighting, as required.
- Keep the work site secure at all times, including after working hours-

Work at site will involve contact with:

- Multi-employer work site.
- Federal employees and general public.
- Working from heights in a federal owned facility is 2.4m
- PSPC Preliminary Hazard Assessment (issued by DR)

Work at sites may involve some or all of the following conditions:

- Confined space and restricted access space.
- Working at heights. (Roof tops, ladders, scaffolding, etc.)
- Working alone.
- Hazardous material. (i.e. asbestos, lead, silica, mold)
- Vehicle traffic.
- Machinery (hot/cold or moving parts).

### 33. UTILITY CLEARANCES

- The Contractor is solely responsible for all utility detection and clearances prior to starting the work (eg. natural gas lines and electrical cables).
- The Contractor will not rely solely upon the Reference Drawings or other information provided for Utility locations.

### 34. REGULATORY REQUIREMENTS

- Comply with specified codes, acts, bylaws, standards and regulations to ensure safe operations at site.
- In event of conflict between any provisions of the above authorities, the most stringent provision will apply. Should a dispute arise in determining the most stringent requirement, the Departmental Representative will advise on the course of action to follow.

### 35. WORK PERMITS

Obtain specialty permit(s) related to project before start of work.

### 36. FILING OF NOTICE

- The General Contractor is to file Notice of Project with Provincial authorities prior to commencement of work. (All construction projects require a Notice of Work).

- Provide copies of all notices to the Departmental Representative.

### 37. SITE SPECIFIC HEALTH AND SAFETY PLAN

1. Conduct a site-specific hazard assessment based on review of Call-up documents, required work, and project site. Identify any known and potential health risks and safety hazards.
2. Prepare and comply with the Site Specific Safety Plan (SSSP) or Health and Safety Plan (HASP) based on the required hazard assessment, including, but not limited to, the following:  
Primary requirements:
  1. Contractor's safety policy.
  2. Identification of applicable compliance obligations
  3. Definition of responsibilities for project safety/organization chart for project.
  4. General safety rules for project.
  5. Job-specific safe work, procedures.
  6. Inspection policy and procedures.
  7. Incident reporting and investigation policy and procedures.
  8. Occupational Health and Safety Committee/Representative procedures.
  9. Occupational Health and Safety meetings.
  10. Occupational Health and Safety communications and record keeping procedures.
  11. COVID 19 Protocols and Procedures
  12. Summary of health risks and safety hazards resulting from analysis of hazard assessment, with respect to site tasks and operations which must be performed as part of the work.
  13. List hazardous materials to be brought on site as required by work. SDS required for all products.
  14. Indicate Engineering and administrative control measures to be implemented at the site for managing identified risks and hazards.
  15. Identify personal protective equipment (PPE) to be used by workers.
  16. Identify personnel and alternates responsible for site safety and health.
  17. Identify personnel training requirements and training plan, including site
3. Develop the plan in collaboration with all subcontractors. Ensure that work/activities of subcontractors are included in the hazard assessment and are reflected in the plan.
4. Revise and update Site Specific Safety Plan (SSSP) or Health and Safety Plan (HASP) as required, and re-submit to the Departmental Representative.
5. Departmental Representative's review: the review of Site Specific Safety Plan or Health and Safety Plan by Public Works and Government Services Canada (PWGSC) shall not relieve the Contractor of responsibility for errors or omissions in final Site Specific Safety Plan and/or Health and Safety Plan of responsibility for meeting all requirements of construction and Call-up documents and legislated requirements.

### 38. EMERGENCY PROCEDURES

1. List standard operating procedures and measures to be taken in emergency situations. Include an emergency response and emergency evacuation plan and emergency contacts (i.e. names/telephone numbers) of:
  - Designated personnel from own company.
  - Regulatory agencies applicable to work and as per legislated regulations.
  - Local emergency resources.
  - Departmental Representative.
  - A route map with written directions to the nearest hospital or medical clinic.
2. Include the following provisions in the emergency procedures:
  - Notify workers and the first-aid attendant, of the nature and location of the emergency.
  - Evacuate all workers safely.
  - Check and confirm the safe evacuation of all workers.
  - Notify the fire department or other emergency responders.
  - Notify adjacent workplaces or residences which may be affected if the risk extends beyond the workplace.

- Notify Departmental Representative.

3. Provide written rescue/evacuation procedures as required for, but not limited to:

- Work at high angles.
- Work in confined spaces or where there is a risk of entrapment.
- Work with hazardous substances.
- Underground work.
- Work on, over, under and adjacent to water.
- Workplaces where there are persons who require physical assistance to be moved.
- Design and mark emergency exit routes to provide quick and unimpeded exit.
- Revise and update emergency procedures as required, and re-submit to the Departmental Representative.
- Contractors must not rely solely upon 911 for emergency rescue in a confined space, working at heights, etc.

### 39. HAZARDOUS PRODUCTS

Comply with requirements of Workplace Hazardous Materials Information System (WHMIS 2015) regarding use, handling, storage and disposal of hazardous materials, and regarding labelling and provision of Safety Data Sheets (SDS) acceptable to the Departmental Representative and in accordance with the Canada Labour Code.

- Where use of hazardous and toxic products cannot be avoided:
- Advise Departmental Representative beforehand of the product(s) intended for use.
- In conjunction with Departmental Representative schedule to carry out work during "off hours" when tenants have left the building.
- Provide adequate means of ventilation.
- The contractor shall ensure that the product is applied as per manufacturer's recommendations.
- The contractor shall ensure that only pre-approved products are bought onto the work site in an adequate quantity to complete the work.

### 40. ASBESTOS HAZARD

- Carry out any activities involving asbestos in accordance with current applicable Federal and Provincial Regulations.
- Removal and handling of asbestos will be in accordance with current applicable Provincial / Federal Regulations.

### 41. PCB REMOVALS

- Mercury-containing fluorescent tubes and ballasts which contain polychlorinated biphenyls (PCBs) are classified as hazardous waste.
- Remove, handle, transport and dispose as per provincial standards.

### 42. REMOVAL OF LEAD-CONTAINING PAINT

1. All paint containing TCLP lead concentrations above 5 ppm are classified as hazardous.
2. Carry out demolition and/or remediation activities involving lead-containing paints in accordance with current applicable Provincial / Territorial Regulations.
3. Work with lead-containing paint shall be completed as per Provincial and Federal Regulations.
4. Dry Scraping/Sanding of any materials containing lead is strictly prohibited.
5. The use of Methylene Chloride based paint removal products is strictly prohibited.

### 43. SILICA

Carry out any activities involving silica in accordance with current applicable Federal and Provincial Regulations.

### 44. ELECTRICAL SAFETY REQUIREMENTS

(Reference: Worksafe BC OHS Regulation Part 19 – Electrical Safety)

1. Comply with authorities and ensure that, when installing new facilities or modifying existing facilities, all electrical personnel are completely familiar with existing and new electrical circuits and equipment and their operation.
2. Before undertaking any work, coordinate arc flash protection, required energizing and de-energizing of new and existing circuits with Departmental Representative.
3. Maintain electrical safety procedures and take necessary precautions to ensure safety of all personnel working under this Call-up, as well as safety of other personnel on site.

#### **45. ELECTRICAL LOCKOUT**

- Develop, implement and enforce use of established procedures to provide electrical lockout and to ensure the health and safety of workers for every event where work must be done on any electrical circuit or facility.
- Prepare the lockout procedures in writing, listing step-by-step processes to be followed by workers, including how to prepare and issue the request/authorization form. Have procedures available for review upon request by the Departmental Representative.
- Keep the documents and lockout tags at the site and list in a log book for the full duration of the SOA. Upon request, make such data available for viewing by Departmental Representative or by any authorized safety representative.

#### **46. OVERLOADING**

Ensure no part of work is subjected to a load which will endanger its safety the safety of personnel and/ or will cause permanent deformation.

#### **47. FALSEWORK**

Design and construct falsework in accordance with CSA S269.1-1975 (R2003). (as amended)

#### **48. SCAFFOLDING**

Design, construct and maintain scaffolding in a rigid, secure and safe manner, in accordance with CSA Z797-2009 (as amended) and B.C. Occupational Health and Safety Regulations. (as amended)

#### **49. CONFINED SPACES**

Carry out work in compliance with current Provincial / Territorial regulations.

#### **50. POWDER-ACTUATED DEVICES**

Use powder-actuated devices in accordance with ANSI A10.3 (as amended) only after receipt of written permission from the Departmental Representative.

#### **51. FIRE SAFETY AND HOT WORK**

1. Obtain Departmental Representative's authorization before any welding, cutting or any other hot work operations can be carried out on site.
2. Hot work includes cutting/melting with use of torch, flame heating roofing kettles, or other open flame devices and grinding with equipment which produces sparks.
3. Hot Work permits are a mandatory requirement for any hot work activities.

#### **52. FIRE SAFETY REQUIREMENTS**

1. Store oily/paint-soaked rags, waste products, empty containers and materials subject to spontaneous combustion in ULC approved, sealed containers and remove from site on a daily basis.
2. Handle, store, use and dispose of flammable and combustible materials in accordance with the National Fire Code of Canada. (as amended)
3. Portable gas and diesel fuel tanks are not permitted on most federal work sites. Approval from the Departmental Representative is required prior to any gas or diesel tank being brought onto the work site.

### **53. FIRE PROTECTION AND ALARM SYSTEM**

1. Fire protection and alarm systems shall not be:
  - Obstructed.
  - Shut off.
  - Left inactive at the end of a working day or shift.
2. Do not use fire hydrants, standpipes and hose systems for purposes other than firefighting.
3. Be responsible/liable for costs incurred from the fire department, the building owner and the tenants, resulting from false alarms.

### **54. UNFORESEEN HAZARDS**

Should any unforeseen or peculiar safety-related factor, hazard or condition become evident during performance of the work, immediately stop work and immediately advise the Departmental Representative verbally and in writing.

### **55. POSTED DOCUMENTS**

1. Post legible versions of the following documents on site:
  - Site Specific Safety Plan (SSSP) or Health and Safety Plan (HASP)
  - Sequence of work.
  - Emergency procedures.
  - Site drawing showing project layout, locations of the first-aid station, evacuation route and marshalling station, and the emergency transportation provisions.
  - Notice of Project.
  - Floor plans or site plans.
  - Notice as to where a copy of the Workers' Compensation Act and Regulations are available on the work site for review by employees and workers.
  - Workplace Hazardous Materials Information System (WHMIS 2015) documents.
  - Material Safety Data Sheets (SDS).
  - List of names of Joint Health and Safety Committee members, or Health and Safety Representative, as applicable.
  - All Hazardous Material and Substance Reports including Lab Analysis
2. Post all Material Safety Data Sheets (MSDS) on site, in a common area, visible to all workers and in locations accessible to tenants when work of this Call-up includes construction activities adjacent to occupied areas.
3. Postings should be protected from the weather, and visible from the street or the exterior of the principal construction site shelter provided for workers and equipment, or as approved by the Departmental Representative.

### **56. MEETINGS**

Attend health and safety pre-construction meeting and all subsequent meetings called by the Departmental Representative.

### **57. CORRECTION OF NON-COMPLIANCE**

1. Immediately address health and safety non-compliance issues identified by the Departmental Representative.
2. Provide Departmental Representative with written report of action taken to correct non-compliance with health and safety issues identified.
3. The Departmental Representative may issue a "stop work order" if non-compliance of health and safety regulations is not corrected immediately or within posted time. The Contractor/subcontractors will be responsible for any costs arising from such a "stop work order".
