Response(s) (R) to Question(s) (Q):

Q1: Would it be possible to have the AutoCad files for this bid ?

R1: The CAD drawings are currently not available for distribution.

Q2: Also, may you please confirm if the lockers required are to be assigned or non-assigned locks ?

R2: Mostly assigned but some may be unassigned.

Q3: Regarding the quantities of the lockers, is it 60 or 120? The delivery and installation tables mention 60 units for the 5th floor and another 60 units for the 6th floor

R3: We are procuring 60 two tiered towers – which would be 120 lockers unit. Each floor would have 30 towers installed, which would be 60 individual locker units.

Q4: The RFB quantity is 60 but the delivery and install tables have 60 units on floor 5 and 60 units on floor 6, which makes 120 units. Please confirm the total quantity required.

R4: Please refer to R3.

Q5: Can you please confirm if you want 60 lockers, or 120 lockers? The product table asks for 60 lockers, but the installation table asks for 60 lockers on the 5th floor and 60 lockers on the 6th floor.
