2. Questions & Answers

- Q1.** Is all material supplied by PCA and available in the Marmot Pit?
A1. Materials specified in the tender documents to be supplied by PCA will be provided from Marmot Pit. Any other materials required by the contractor to complete the work will have to be sourced by the contractor outside the Park.
- Q2.** Are we reusing the ground screws? There is 8 weeks lead time to supply new ones.
A2. Yes, reusing existing, please refer to contract documents.
- Q3.** Can waste material be left on site or must be hauled to the Marmot Pit?
A3. Excess material to be hauled to the Marmot Pit. Where noted in the tender documents, some excavated materials can be wasted on site. Please refer to tender documents.
- Q4.** Can the washrooms be closed when working around them?
A4. No.
- Q5.** Traffic accommodation responsibility?
A5. The responsibility for traffic accommodation and work site safety lies with the contractor. Campground will be open during construction. Only selected campsites, adjacent to the construction work, were closed for camping until June 2nd. Please refer to tender documents for details.
