Α. Solicitation Revisions

COVID-19 Vaccination Requirement

This requirement provides arrangements for a site visit that is subject to the COVID-19 Vaccination Policy for Supplier Personnel. Bidders who do not confirm attendance, provide the name(s) of the person(s) who will attend, or who do not complete and submit the requested certification as required will not be allowed access to the site.

1.4 **Optional Site Visit**

It is recommended that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for the site visit to be held at Gros Morne Swimming Pool on May 11, 2022. The site visit will begin at 10 am NDT.

Bidders are requested to communicate with the Contracting Authority no later than May 10, 2022 at 2 pm NDT to confirm attendance and provide the name(s) of the person(s) who will attend. Bidders may be requested to sign an attendance sheet. Bidders who do not attend or do not send a representative will not be given an alternative appointment but they will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.

- Q1. We need to know the number of swimming instructors in the mornings to be able to calculate the cost of salaries.
- R1. Seven groups are generally seen as the capacity for lessons. Meeting PC service expectations for this contract, a minimum of 5 instructors is needed to be available for lessons.
