If not, how should we present their experience?	No, Phase 1 (RFQ) is to assess the capacity of the Consultant or Joint Venture. Individuals or/and Sub-Consultants will be assessed in Phase 2 (RFP).
4	In item P7, you refer to partner firms in the same country or internationally. Is this partner the current partner for this mandate or is it rather the partner who carried out the project presented?	We seek to understand how the Consultant or the Joint Venture collaborated and maintained communication with the Architects within the project(s) presented.
5	What happens if a project is not recently completed, if it was completed more than 10 years ago (e.g. a 12-year-old project, but which met all the other criteria)? Will this project be disqualified or lose points (and by how much)?	Refer to document change no.2. The project will be accepted and evaluated with the rated requirements from P1 to P7.
