Question:

Due to supply chain issues and constraints it is not possible to deliver the requested system before 8 July 2022. Will Canada accept delivery before March 31, 2023?

Answer:

The delivery date cannot be delayed as this system is required for a refit taking place this summer.

Question and Answer 2.

Question:

Considering the number of technical and contractual requirements of this solicitation we kindly request to extend the closing date for 4 weeks to allow all qualified suppliers prepare and complete a proposal. The initial period of this solicitation is not enough considering the scope of work.

Answer:

Delaying the closing date by 4 weeks would affect the delivery date so Canada agrees to extend the closing date by 2 weeks until 31 May 2022.
